

Overview

The Planning Department reviews new business licenses, and existing licenses at new locations, to ensure that businesses comply with the Zoning Ordinance, Building Code, and other applicable regulations. There are three main steps in this review (see chart on reverse):

- 1. Address Verification
- 2. Zoning Research and Compatibility
- 3. Site Inspections by Required Agencies

1. Address Verification

Why is an address verification required?

Many addresses are not included in the City's electronic address database. In these cases, the legality of the tenant space must be verified, and the database must be updated before any new business licenses can be approved.

How can I find out if my address is in the City's Database?

Log on to www.cityofberkeley.info/planning/ and click on the parcel conditions link on the left to see if your address exists in the City's database. This information can also be obtained by visiting the Permit Service Center and speaking to a planner at the Zoning Counter.

If your address, including suite number or designated tenant space, is in the electronic database then you may proceed to Step 2.

Staff will verify that the address shown on your application is included in the City's computer

records. If you are located in a commercial building with multiple suites, staff needs to verify that the suite addresses were legally established. If they were not, you will need to apply for an address assignment before the business license application will be accepted. The address assignment is \$340, the property owner must sign the application, and the process takes four – six weeks.

To expedite this process, you should check early in the process to determine if you have an approved address, including a suite address if applicable. This process can take several weeks, so it is important for businesses to initiate the process early. See reverse for how to obtain this application on the web.

*Note: Zoning review may be conducted while address assignment is pending, but zoning approval cannot be granted until address assignment is completed.

2. Zoning Research and Compatibil-

What is the Zoning Ordinance and how does it affect my business?

An important part of the City's approval of a business license is review by Planning Department staff to be sure that your business is a permitted use in your proposed location. The Zoning Ordinance identifies what types of business are allowed in the various zoning districts, as well as what types of permit may be required. For example, some businesses may require approval of an Administrative Use Permit or approval from the Zoning Adjustments Board.

Once you have confirmed that your address is in the City's database please talk to a planner at the Zoning Counter in the Permit Service Center to verify that your business is allowed in, and compatible with the purposes and uses allowed in the district. Once Zoning staff grants permission to establish the use, they will sign off on your business license application.

*Note: Do not sign a lease until you have verified that the address exists and the use is compatible with the purposes and uses within the district.

3. Site Inspections

Why are site inspections required?

Depending on the type of business you operate, the Finance Department will require you to obtain signatures from various city agencies to verify that your building and operational practices are up to code.

The Fire Department conducts inspections to verify that fire prevention measures meet basic life safety requirements. Questions about fire prevention should be directed to 981-5585.

The Environmental Health Department conducts inspections to verify that operational practices promote and protect the health and safety of all persons in the City of Berkeley. Questions about environmental health should be directed to 981-5310.
