Subject: Confirming the Results of the April 16, 2024, Special Municipal Election

RECOMMENDATION

Adopt a Resolution confirming the results of the April 16, 2024 Special Municipal Election for City Council District 7.

FISCAL IMPACTS OF RECOMMENDATION

There are no fiscal impacts associated with confirming the election results.

CURRENT SITUATION AND ITS EFFECTS

The Alameda County Registrar of Voters has submitted to the City Clerk the official Statement of Votes Cast for the City of Berkeley Special Municipal Election held on April 16, 2024, and the City Clerk has prepared the attached Certification of Election Results.

The attached Resolution confirms the results of the April 16, 2024 Election and declares Cecilia Lunaparra as the candidate elected to the office of City Council District 7.

For the certified results, the precint count shows 197 votes for James Chang, but the RCV report shows 198 votes. This is due to an "advanced vote" that is tabulated when the RCV algorithm is used. An example of an advanced vote scenario would be if a voter left their first choice column blank, but then voted for James Chang in the second choice column. When the ROV runs the RCV algorithm, the vote in the second choice column is "advanced" to the first choice column. This is how the system has worked since its inception in 2010 and is the proper outcome in these scenarios.

BACKGROUND

With the resignation of Councilmember Robinson on January 12, 2024, a vacancy was created in the office of City Councilmember for District 7. The District 7 seat is on the regular rotation to be filled at the 2026 municipal election. According to the City Charter (Article V, Section 12) if there is more than one year remaining on the term of the vacant seat, the City Council must call a special election to fill the vacancy within 10 days of the occurrence of the vacancy (January 12). On January 22, the Council called for the special election to be held on April 16.

ENVIRONMENTAL SUSTAINABILITY AND CLIMATE IMPACTS

There are no identifiable environmental and climate effects or opportunities associated with confirming the election results.
