To whom it may concern,

We as Youth Commissions are writing to you with our own urges and concerns of the rise in COVID-19 and the sweeping Omicron variant. On Tuesday, January 4th, The California Department of Public Health reported more than 230,000 new cases. On that same day, over 8,300 cases were reported in Berkeley, CA alone. The day before, January 3rd, the 7-day average was reported to be 14.4%, up about 5% from just a few days before. These tests do not fully take into account the Holiday parties as well as high rates of travel in the Bay Area throughout winter break.

When looking at these numbers, it is important to keep in mind that many cases go unreported, untested and undetected. Additionally, the New York Times reports that Alameda County's 14-day change is +666%. These statistics have all dramatically risen with the introduction of Omicron into our community. We have yet to even see the peak of Omicron cases yet - the worst is yet to come. We have an opportunity to do something before the worst of it is here. When BUSD first went into quarantine, the number of cases present in BUSD was significantly lower than they are now, even though we have no safety precautions in place now.

What we are asking for is for the school board to work with BUSD schools to come up with a solution for students who don't feel safe coming to school right now with the new variant becoming so widespread. A complete lockdown might not be feasible nor beneficial to the majority of the BUSD community, so this is a request for a separate and optional route for remote learning that students and families can elect to take that will reap no punishment or negative consequences on the student.

COVID-19 has changed the way we need to think and operate. Students safety should be a number one priority; right now, many students are not feeling like that priority is being taken seriously.

Here are some Anonymous statements from BUSD students on how they are feeling about the return to school after being asked, "Do you feel safe at school with the heavy rise in COVID-19 and Omicron cases" on Commissioner Lamoreaux's public instagram account. 76% of respondents answered "NO" to the question:

#### BHS Student in 12th Grade:

"Many kids just came home from break the day before school, and those kids won't show up positive on the antigen tests, meaning they will think it's okay to hang out with friends, who will hang out with more people causing a massive spread."

### BHS Student in 11th Grade:

"People are dropping every day and it's insane. I was sitting next to someone the other day who is now out and sick with COVID."

### BHS Student in 12th Grade:

"I'm staying home this week because I don't feel comfortable going to a school with 3,000+ kids during this Omicron outbreak. My family has pre-existing health conditions and I can't risk passing COVID-19 on to them. I'm facing serious truancy claims because the district will no longer allow my mother to excuse my absences without a doctor's note... I'm not sick, but I know I will be if I go to school right now."

#### BHS Student in 12th Grade:

"Even though the school tried to reinforce mandates, you can't trust people and most of them don't follow the rules, being selfish and exposing everyone else."

#### BHS Student in 11th Grade:

"My boyfriend and I recently got COVID-19, and many of the students in our classes aren't even at school despite being sick or not because it's such a contagious virus and variant. There's more covid cases in school now then when we were all in distance learning."
