

FINAL PROJECT TITLE & DESCRIPTION:

Mundane Times - stories of connection through a lonely year

Mundane Times is a free illustrated newspaper, celebrating ordinary moments that have connected us to each other and to our communities throughout the pandemic. Stories were gathered from the Berkeley community - then compiled, written, and illustrated by artist Kate Pocrass. Mundane Times serves as a time capsule for these unprecedented times when it was difficult to connect with fellow neighbors or strike up a conversation with a stranger. It shows that the connections we make were not lost, rather scarcity made them even more meaningful.

DIMENSIONS 19" wide 16" deep 36" high 65lbs


PLACEMENT

Each box will be placed on site working with owner/manager of the property. Boxes placed on sidewalks will have a 4' clear path of travel for ADA compliance. Boxes on sidewalks will ideally live in the "furnishing zone" when applicable.

MATERIALS

Boxes are made from durable steel & can withstand all weather elements. The front glass is "Lexan" a very strong plastic.





KATE POCRASS

FINAL PROJECT LOCATION:

Readers will be able to pick up the newspaper from two metal newspaper boxes that will rotate throughout the city. The boxes will live at each location for two weeks before being moved to the next site.

Secured Locations:

Acme Bread

- Box will be located on the step up between the former location of Bartavelle Café and queue for Acme bread. Box will be weighted and secured with a lock to the neighborhing post.
- This is private property and permission has been granted by both Acme Bread & Kermit Lynch. Location was decided on by all parties as to be accesible but not interfer with their ease of operation.

Subway Guitars

- Box will be located to the left of the front door in the building's inset from the sidewalk. Box will be
 weighted and secured with a bracket & concrete nails. Nail whole will be filled in once boxes are
 removed.
- Permission was granted from Subway Guitars. Per Vincent Chen at the Berkeley Permitting Service Center – an engineering permit application for this site will be submitted.

Standard Fare

- Box will be located in the parklet. Box will be weighted and secured with a bracket & concrete nails. Nail
 whole will be filled in once boxes are removed.
- Permission was granted from Standard Fare. Box is considered parklet furntiure and will not interfere with sidewalk access.

59 Arden Rd.

- Box will be located on the home owners property at Arden Rd & Orchard Ln. Access to the papers will
 be adjacent to the Orchard Lane steps. Box will be weighted and secured with a lock to the neighborhing
 fence post.
- This is private property and permission was granted by the homeowner. There is no sidewalk at this location.

Additional Pending Locations:

Nick's Pizza

- Box will be located in the courtyard eating area in front of the restaurant. Box will be weighted and secured with a lock to the neighborhing post.
- This is private property. Location is pending permission from business owner.

Everett Jones BBQ

- Box will be located in the courtyard eating area in front of the restaurant. Box will be weighted and secured with a lock to the neighborhing post.
- This is private property. Location is pending permission from business owner.

Downtown Berkeley Bart Plaza

- In contact with Matthew Jervis about finding a downtown buisness partner for this location. Box will be
 weighted and secured with a bracket & concrete nails. Nail whole will be filled in once boxes are
 removed.
- Per Vincent Chen at the Berkeley Permitting Service Center an engineering permit application for this site will be submitted.

Public Library Locations

- Newspaper bins/racks will be distributed to all 5 branches of the Berkeley Public Library. (Central Library, Claremont Branch, North Branch, Tarea Hall Pitman South Branch, West Branch.)
- Working with Aimee Reader in Communications on the logistics.

In addition to the newspaper, participants will be able to call a weekly *Mundane Times* hotline, showcasing a different *Mundane Times* story or location to visit. The hotline will make the project more accessible to those who are unable to pick a newspaper up in person.

Title

Berkeley Big Book Mural

Timeline

September 13th – Clean/prepare site. (power-wash)

September 14th – Day 1 of painting (layout and color blocking)

September 15th – Day 2 of painting (finish color-blocking and start linework)

September 16th – Day 3 of painting (finish linework and touchups)

September 17th – Clear anti-graffiti coating

Final Budget

\$250 Paint and supplies \$1750 Artist fee (design and installation)

Location


Approximately 8ft x 14ft (including the 20' inset) wall near to the left of the Center street entrance of the Allston Way Garage at 2052 Center St. Berkeley, CA 94704.

Design

This whimsical mural depicts an open book that is erupting with knowledge in the form of Berkeley themed iconography as well as some scholarly dogs and cats. The message being a simple reminder of the joy of reading a book. A positive universal message that is fitting in this location across from Berkeley City College and is in close proximity to many other notable educational institutions.

The image is fun, dynamic, and also give the viewer plenty of details to relate to and allow for a moment of personal connection and discovery. Final design dependent on approval from Building Owner and Downtown Berkeley Association.

The colors where chosen to fit in with the rest of building while acting as a lively and unexpected pop of color.
