He shared that new information found that drones were not flown over Berkeley airspace and that the Alameda County Sheriff's Office (ASCO) was there with the drones on a standby basis. The drones were used for two calls of service but they were not within Berkeley airspace. In recognition that BPD may want to use drones in the future, he notified the PAB that a policy will be coming to the Board for feedback in the coming weeks.
- Captain Durbin provided an update on the policies that are still to be converted to the Lexipol format and other policies of interest to the PAB.
- Captain Durbin reported that there is one new officer and one new communication manager at BPD. There is a draft proposal for a recruitment and incentive program pending review by the city manager.
- Updates on the arrest regarding the October 8th shooting near UC Berkeley and a shooting during a catalytic converter theft. There are also updates regarding firearms recovered within the city through a variety of methods.
