The City of Berkeley is soliciting written proposals from qualified Community-Based Organizations (CBOs) serving Berkeley with a community-based focus to **promote reduction of consumption of sugar-sweetened beverages and to address the effects of sugar-sweetened beverage consumption on health.**

The **Healthy Berkeley Program** within the Public Health Division of the City of Berkeley is pleased to release its new Request for Proposals (RFP) for **FY2022 and FY2023 (July 1, 2021 through June 30, 2023).**

The project scope, type of proposals sought, and vendor selection process are summarized in the RFP (attached). **Proposals must be received no later than 5 p.m., Thursday, February 25, 2021** via electronic submission (instructions below). **Late applications will be denied. The funding application will only be accepted online at www.citydataservices.net.** Hard copies will **not** be considered.

I. BACKGROUND/INTRODUCTION

A. Current Situation

COVID-19 has been part of our shared experience for nearly three years, and the higher risk for severe COVID-19 outcomes among persons of color is noteworthy. Latinx and African American communities have experienced higher hospitalization and death rates than white people. These serious outcomes have been linked to underlying conditions including type-2 diabetes, heart disease, stroke, and obesity and have led to a downturn in life expectancy. Type-2 diabetes, heart disease, and obesity have also been linked with increased consumption of sugar-sweetened beverages (SSBs). Revenues from the Berkeley SSB tax have the potential to raise awareness of the health effects from the consumption of SSBs and put in place practices and policies that can actually help to reduce health disparities in our city. Health disparities, as documented in the 2018 City of Berkeley Health Status Report (hereafter referred to as Report), were an important impetus for passing Measure D in 2014. Healthy Berkeley aims to invest in school and community educational programs and policies to reduce health disparities.

Health inequities are defined as “differences in health, which are not only unnecessary and avoidable but, in addition are unfair and unjust.”

The Report states that “a truly healthy Berkeley depends on achieving and maintaining optimal health and wellness for all people regardless of an individual’s or group’s position in society.” Health inequities have been highlighted in the Report for over 20 years. For example, when the sugary drink tax passed in Berkeley, African Americans were more likely to have type-2 diabetes, to be obese, and be hospitalized for diabetes than their white counterparts. Significant economic disparities are also noted in the Report: the proportion of families living in poverty is 8 times higher among African American families, 5 times higher among Latinx families, and 3 times higher in Asian families, compared to white families.

B. Funding Goals

Health disparities are related to economic and social inequities that are evident in the unequal food and beverage environments in Berkeley. The SSBPPE seeks to reduce these health disparities and underlying conditions. We encourage proposals in the following 3 categories:

1. **Education & Marketing/Communications Campaigns:** school- and community-based efforts to change community norms and reduce the consumption of sugary drinks;
2. **Policy:** development, implementation and strengthening of laws, ordinances, rules and regulations that prevent or at least restrict access to sodas and other unhealthy beverages and promote access to water and other healthy beverages, especially in stores and institutions in priority communities.
3. **Chronic Disease Prevention and Health Screenings:** programs that address the negative health effects of sugar sweetened beverage consumption, with an emphasis on dental health.

The SSBPPE will review and recommend proposals for funding in each of the above categories. We understand that some applicants will utilize multiple strategies and we support a multi-prong approach that strengthens the overall goals of the proposal. We also encourage applicants to collaborate with other Healthy Berkeley grantees.

We envision recommending the majority of funding for community-based applications in the realm of community norms change, prevention activities with an emphasis on dental health, direct services, and referrals (including dental screenings and diabetes prevention programming). We hope some of the community funding will go towards applications that focus on policies that create a healthier food and beverage environment in Berkeley, and we would like to address and counter the beverage industry’s marketing to those who are at higher risk for type 2 diabetes, heart disease, obesity, and COVID-19.

Additionally, for applicants who have received previous funding, we are interested in how you will build on past accomplishments. Will your project reach new participants? Does your proposal describe deeper engagement with the same community members in new ways that reinforce and build upon previous funding? Does your project include a plan to communicate how you are using Healthy Berkeley funding to improve people's health with the broader community?

C. Background/History

In November of 2014, Berkeley voters passed Measure D with the intent "to diminish the human and economic costs of diseases associated with the consumption of sugar-sweetened beverages - by discouraging their distribution and consumption in Berkeley through a tax." Measure D provided for the establishment of a Panel of Experts (SSBPPE) to advise the City Council on "how and to what extent the City should fund programs to further reduce the consumption of sugar-sweetened beverages in Berkeley and address the consequences of such consumption."

Since inception, Measure D funds have made possible investments in school-based gardening and cooking programs in the amount of \$4,700,000. These funds have also provided \$4,700,000 for community led and delivered programming to support norms change. The City of Berkeley has also received \$1,850,000 to staff the commission, to administer and coordinate the Healthy Berkeley program, and to engage in heightened evaluation as recommended by the SSBPPE.

D. Funding Amount Available

Per Council Resolution No. 69,669-N.S. adopted on December 15, 2020, the Berkeley City Council has allocated a total of \$2,662,506 (\$1,331,253 per year for FY22 and FY23) to be distributed for two-year grants to be administered and coordinated by the Public Health Division consistent with the SSBPPE's funding recommendations to *reduce the consumption of sugar-sweetened beverages* in Berkeley and to *address the effects on health of sugar-sweetened beverage consumption*. A minimum of 42.5% of the total allocation per year is allocated for community grants and up to 42.5% of the total allocation per year is allocated for BUSD's nutrition education, garden and cooking program. Funding is authorized for the period from July 1, 2021 through June 30, 2023. **No single agency or organization may receive more than 50 percent of the funds allocated for community grants. The grant minimum is \$10,000.** Priority will be given to Berkeley-based organizations serving the population of Berkeley.

II. SCOPE OF SERVICES

A. Objectives and Strategies

The primary goal of this funding opportunity is to invest in the health of the Berkeley community, especially the priority populations that are targeted by beverage industry practices and who collectively experience the worst health outcomes related to the overconsumption of sugary drinks. Consistent with the intent of passing the local soda tax, the SSBPPE encourages strategies that support programming and activities that transform the policies, systems, and norms that underlie high rates of soda consumption for the funding periods July 1, 2021 through June 30, 2022 (FY22) and July 1, 2022 through June 30, 2023 (FY23).

A.1. Strategies that address the goals and objectives of this funding include:

- Transforming the systems, policies, environments, structures, and norms that underlie sugary drink consumption.
- Developing community capacity to improve health by transforming systems, policies, environments, structures, and norms through increasing leadership potential of community members and young people, especially those serving priority populations.
- Supporting community programming designed to change norms to support consumption of healthy food and beverages.
- Providing health screenings and chronic disease prevention with a focus on dental health.
- Impacting sugary drink marketing and retail environments (i.e., availability, promotion, price, placement in convenient stores, and advertising), especially those that disproportionately target priority populations.

- Improving access to, and the production of, healthy foods and drinks for priority populations in Berkeley.
- Communication of efforts and activities to the broader community.

B. Priority Populations include:

- Children and their families - with an emphasis on young children who are in the process of forming lifelong habits;
- Children and young adults living in households with limited resources;
- African Americans and Latinx – these communities have higher than average population levels of type 2 diabetes, heart disease, obesity, and tooth decay rates;
- African Americans, Latinx, low income communities and teens because these are all groups disproportionately targeted by the beverage industry’s marketing.
- Pregnant women
- Berkeley-based organizations that serve any or all of the above populations.

C. Examples of Potential Projects:

1. Policies and organizing efforts that reduce the marketing, availability and consumption of sugary drinks in stores and restaurants.
2. Policies that remove vending machines or require healthy beverages in vending machines.
3. Projects that work with grocery stores and convenience markets to remove window advertising for sugary drinks and to encourage their commitment to this practice and establish store policy.
4. Projects that educate store owners and managers about how the funds made available through the passage of Measure D support school and community efforts to improve the health of Berkeley residents.
5. Projects that promote healthy beverage consumption and secure pledges from consumers not to purchase or drink sugary beverages.
6. Public mural projects that reflect the culture of priority groups and counter beverage industry marketing by focusing on healthy lifestyle images and environments.
7. Projects that build and support community capacity to deliver programming, advocacy, or leadership to motivate healthy norms around beverage consumption.
8. Projects to train and support community leaders (eg: promoters, peer to peer, water ambassadors, etc.) including adult residents and young organizers, to engage in campaigns to change systems, structures, policies, and environments resulting in more healthful beverage consumption.
9. Projects that engage community leadership to improve food and beverage environments in existing institutions including schools, universities, municipal sites, faith organizations, and private and public spaces.
10. Projects that directly engage members of priority populations in programs and activities that are designed to improve the food and beverage environment including nutrition education, gardening, and cooking in school and community settings.
11. Projects that collaborate with youth and adult sports leagues to encourage norms change toward healthier hydration through policies, parent/participant education, and infrastructure development.
12. Projects that improve access to tap water.
13. Projects that educate the greater Berkeley community on how the funds made available through the passage of Measure D support school and community efforts to improve the health of Berkeley residents. Methods to do this might include planning a panel discussion, submitting an op-ed to the newspaper, using social media.

Note: Priority will be given to proposals that have a high impact on the priority populations in Berkeley and are designed to create sustainable change that lasts over the years and to those proposals which include ways to communicate their efforts to the broader community .

The Health, Housing & Community Services (HHCS) Department at the City of Berkeley is committed to finding ways to deepen our positive impact on the community, especially for those most vulnerable. To support this effort, HHCS will use a framework called Results Based Accountability (RBA) that has a proven track record of success in improving the quality of life for people and communities. RBA will provide us with a common language and method to better understand, communicate, and ultimately strengthen our programs.

HHCS is incorporating RBA into our contract processes including requests for proposals, reporting, contract monitoring activities and evaluations. All new or renewed contracts will provide information and data that address the three basic RBA questions: "How much work was done? How well was it done? and, Are agency clients better off as a result of the services provided?." Providers can expect to be asked how they measure whether clients are better off and the quality of the delivered services. HHCS will work with providers to identify appropriate performance measures including service measures and outcomes. Processes will be developed to monitor and improve performance over time. IV. SELECTION CRITERIA

The following criteria and attached screening questions (**Attachment M**) will be considered, although not exclusively, in determining which proposals are funded:

1. The proposal aims to decrease consumption of sugary drinks, increase access to drinking water, and/or address health effects from consumption of sugary drinks (25%)
2. The proposal reaches people and communities in the priority populations. (25%)
3. Project provides lasting impact beyond the grant period: i.e. builds organizational and community capacity and/or changes systems and policies, and environments related to SSBs. (25%)
4. The proposal includes a plan for communicating efforts, activities, and/or successes to the larger Berkeley community. (15%)
5. Proposal budget matches the work plan and is appropriate. (10%)

Two (2) selection panels will be convened as follows to review the grant applications:

1. SSBPPE Commission Panel, comprised of appointed leaders in health promotion, equity, programming and evaluation, has a statutory responsibility to make recommendations to the Berkeley City Council on how to invest funds in a manner that advances the Measure D intent language.
2. Public Health Staff Panel provides administrative review support to ensure compliance with Measure D legislation, vendor history and past performance, and compliance with City of Berkeley funding requirements.

V. PAYMENT

Payments: The City will make payment to the vendor within 30 days of receipt of a correct and complete invoice.

VI. CITY REQUIREMENTS

A. Non-Discrimination Requirements:

Ordinance No. 5876-N.S. codified in B.M.C. Chapter 13.26 states that, for contracts worth more than \$3,000 bids for supplies or bids or proposals for services shall include a completed Workforce Composition Form. Businesses with fewer than five employees are exempt from submitting this form. (See B.M.C. 13.26.030)

Under B.M.C. section 13.26.060, the City may require any bidder or vendor it believes may have discriminated to submit a Non-Discrimination Program. The Contract Compliance Officer will make this determination. This applies to all contracts and all consultants (contractors). Berkeley Municipal Code section 13.26.070 requires that all contracts with the City contain a non-discrimination clause, in which the contractor agrees not to discriminate and allows the City access to records necessary to monitor compliance. This section also applies to all contracts and all consultants. **Bidders must submit the attached Non-Discrimination Disclosure Form with their proposal**

B. Nuclear Free Berkeley Disclosure Form:

Berkeley Municipal Code section 12.90.070 prohibits the City from granting contracts to companies that knowingly engage in work for nuclear weapons. This contracting prohibition may be waived if the City Council determines that no reasonable alternative exists to doing business with a company that engages in nuclear weapons work. If your company engages in work for nuclear weapons, explain on the Disclosure Form the nature of such work. **Bidders must submit the attached Nuclear Free Disclosure Form with their proposal.**

C. Oppressive States:

The City of Berkeley prohibits granting of contracts to firms that knowingly provide personal services to specified Countries. This contracting prohibition may be waived if the City Council determines that no reasonable alternative exists to doing business with a company that is covered by City Council Resolution No. 59,853-N.S. If your company or any subsidiary is covered, explain on the Disclosure Form the nature of such work. **Bidders must submit the attached Oppressive States Disclosure Form with their proposal.**

D. Sanctuary City Contracting Ordinance:

Chapter 13.105 of the Berkeley Municipal Code prohibits the City from granting and or retaining contracts with any person or entity that provides Data Broker or Extreme Vetting services to the U.S. Immigration and Customs Enforcement Division of the United States Department of Homeland Security (“ICE”). **Bidders must submit the attached Sanctuary City Compliance Statement with their proposal.**

E. Conflict of Interest:

In the sole judgment of the City, any and all proposals are subject to disqualification on the basis of a conflict of interest. The City may not contract with a vendor if the vendor or an employee, officer or director of the proposer's firm, or any immediate family member of the preceding, has served as an elected official, employee, board or commission member of the City who influences the making of the contract or has a direct or indirect interest in the contract.

Furthermore, the City may not contract with any vendor whose income, investment, or real property interest may be affected by the contract. The City, at its sole option, may disqualify any proposal on the basis of such a conflict of interest. **Please identify any person associated with the firm that has a potential conflict of interest.**

F. Berkeley Living Wage Ordinance:

Chapter 13.27 of the Berkeley Municipal Code requires that contractors offer all eligible employees with City mandated minimum compensation during the term of any contract that may be awarded by the City. If the Contractor is not currently subject to the Living Wage Ordinance, cumulative contracts with the City within a one-year period may subject Contractor to the requirements under B.M.C. Chapter 13.27. A certification of compliance with this ordinance will be required upon execution of a contract. The current Living Wage rate can be found here: https://www.cityofberkeley.info/Finance/Home/Vendors_Living_Wage_Ordinance.aspx. The Living Wage rate is adjusted automatically effective June 30th of each year commensurate with the corresponding increase in the Consumer Price Index published in April of each year. If the Living Wage rate is adjusted during the term of your agreement, you must pay the new adjusted rate to all eligible employees, regardless of what the rate was when the contract was executed.

G. Berkeley Equal Benefits Ordinance:

Chapter 13.29 of the Berkeley Municipal Code requires that contractors offer domestic partners the same access to benefits that are available to spouses. A certification of compliance with this ordinance will be required upon execution of a contract.

H. Statement of Economic Interest:

The City's Conflict of Interest Code designates "consultants" as a category of persons who must complete Form 700, Statement of Economic Interest, at the beginning of the contract period and again at the termination of the contract. The selected contractor will be required to complete the Form 700 before work may begin.

VII. OTHER REQUIREMENTS

A. Insurance

The selected contractor will be required to maintain general liability insurance in the minimum amount of \$2,000,000, automobile liability insurance in the minimum amount of \$1,000,000 and a professional liability insurance policy in the amount of \$2,000,000 to cover any claims arising out of the performance of the contract. The general liability and automobile insurance must name the City, its officers, agents, volunteers and employees as additional insureds.

B. Worker's Compensation Insurance:

A selected contractor who employs any person shall maintain workers' compensation insurance in accordance with state requirements. Sole proprietors with no employees are not required to carry Worker's Compensation Insurance.

C. Business License

Virtually every contractor that does business with the City must obtain a City business license as mandated by B.M.C. Ch. 9.04. The business license requirement applies whether or not the contractor has an office within the City limits. However, a "casual" or "isolated" business transaction (B.M.C. section 9.04.010) does not subject the contractor to the license tax. Warehousing businesses and charitable organizations are the only entities specifically exempted in the code from the license requirement (see B.M.C. sections, 9.04.295 and 9.04.300). Non-profit organizations are granted partial exemptions (see B.M.C. section 9.04.305). Persons who, by reason of physical infirmity, unavoidable misfortune, or unavoidable poverty, may be granted an exemption of one annual free license at the discretion of the Director of Finance. (see B.M.C. sections 9.04.290).

Vendor must apply for a City business license and show proof of application to Purchasing Manager within seven days of being selected as intended contractor.

The Customer Service Division of the Finance Department located at 1947 Center Street, Berkeley, CA 94704, issues business licenses. Contractors should contact this division for questions and/or information on obtaining a City business license, in person, or by calling 510-981-7200.

D. Recycled Paper

Any printed reports for the City required during the performance of the work shall be on 100% recycled paper, and shall be *printed on both sides of the page* whenever practical.

E. State Prevailing Wage:

Certain labor categories under this project may be subject to prevailing wages as identified in the State of California Labor Code commencing in Section 1770 et. seq. These labor categories, when employed for any "work performed during the design and preconstruction phases of construction including, but not limited to, inspection and land surveying work," constitute a "Public Work" within the definition of Section 1720(a)(1) of the California Labor Code requiring payment of prevailing wages.

Occupational Categories

Officials and Administrators - Occupations in which employees set broad policies, exercise overall responsibility for execution of these policies, or provide specialized consultation on a regional, district or area basis. Includes: department heads, bureau chiefs, division chiefs, directors, deputy superintendents, unit supervisors and kindred workers.

Professionals - Occupations that require specialized and theoretical knowledge that is usually acquired through college training or through work experience and other training that provides comparable knowledge. Includes: personnel and labor relations workers, social workers, doctors, psychologists, registered nurses, economists, dietitians, lawyers, systems analysts, accountants, engineers, employment and vocational rehabilitation counselors, teachers or instructors, and kindred workers.

Technicians - Occupations that require a combination of basic scientific or technical knowledge and manual skill that can be obtained through specialized post-secondary school education or through equivalent on-the-job training. Includes: computer programmers and operators, technical illustrators, highway technicians, technicians (medical, dental, electronic, physical sciences) and kindred workers.

Protective Service Workers - Occupations in which workers are entrusted with public safety, security and protection from destructive forces. Includes: police officers, fire fighters, guards, sheriffs, bailiffs, correctional officers, detectives, marshals, harbor patrol officers, and kindred workers.

Para-Professionals - Occupations in which workers perform some of the duties of a professional or technician in a supportive role, which usually requires less formal training and/or experience normally required for professional or technical status. Such positions may fall within an identified pattern of a staff development and promotion under a "New Transporters" concept. Includes: library assistants, research assistants, medical aides, child support workers, police auxiliary, welfare service aides, recreation assistants, homemaker aides, home health aides, and kindred workers.

Office and Clerical - Occupations in which workers are responsible for internal and external communication, recording and retrieval of data and/or information and other paperwork required in an office. Includes: bookkeepers, messengers, office machine operators, clerk-typists, stenographers, court transcribers, hearings reporters, statistical clerks, dispatchers, license distributors, payroll clerks, and kindred workers.

Skilled Craft Workers - Occupations in which workers perform jobs which require special manual skill and a thorough and comprehensive knowledge of the processes involved in the work which is acquired through on-the-job training and experience or through apprenticeship or other formal training programs. Includes: mechanics and repairpersons, electricians, heavy equipment operators, stationary engineers, skilled machining occupations, carpenters, compositors and typesetters, and kindred workers.

Service/Maintenance - Occupations in which workers perform duties which result in or contribute to the comfort, convenience, hygiene or safety of the general public or which contribute to the upkeep and care of buildings, facilities or grounds of public property. Workers in this group may operate machinery. Includes: chauffeurs, laundry and dry cleaning operatives, truck drivers, bus drivers, garage laborers, custodial personnel, gardeners and groundskeepers, refuse collectors, and construction laborers.

21a. Allocation of \$3 Million Over Two Years, FY 2024 and FY 2025, to Reduce Consumption and Health Impacts of Sugar-Sweetened Beverages (SSBs). From: Sugar Sweetened Beverage Product Panel of Experts

Recommendation:

Adopt a Resolution allocating \$3 million from the General Fund in FY24 (July 1, 2023 through June 30, 2024) and FY25 (July 1, 2024 through June 30, 2025) that shall be invested in a grant program administered and coordinated by the Department of Health, Housing, and Community Services' (HHCS) Public Health Division (HHCS/PHD) consistent with the Sugar-Sweetened Beverage Product Panel of Experts (SSBPPE) Commission's goals to reduce the consumption of sugar sweetened beverages (SSB) in Berkeley and to address the health effects of SSB consumption. The total of \$3 million will be distributed in two installments of \$1.5 million per year for FY24 and FY25. In each of these years, the funds will be distributed as follows:

- a. Direct the City Manager to award up to 42.5% of the allocated funds to Berkeley Unified School District (BUSD) through a grant proposal to reduce the consumption of sugar-sweetened beverages (SSBs) through the implementation and enhancement of the BUSD cooking and gardening programs. The BUSD funding process is separate from the RFP process for the general community-based organization funding process and shall be guided by the SSBPPE Commission's Criteria for BUSD Funding.
- b. Direct the City Manager to award at least 42.5% of the allocated funds through an RFP process managed by HHCS/PHD for grants to community-based organizations consistent with the SSBPPE Commission's goals to reduce the consumption of SSBs and to address the effects of SSB consumption. The community-based organization funding RFP process is separate from the BUSD funding process and shall be guided by the SSBPPE Commission's Criteria for Community Agency Grants.
- c. Direct the City Manager to utilize up to 15% of the allocated funds to support HHCS/PHD to coordinate and monitor the grant process, coordinate the overall program evaluation, and produce an annual report that disseminates process and outcome data from the epidemiologist resulting from the SSBPPE Commission funding program as well as pay certain City of Berkeley Finance Department costs related to the sugary drink tax.

Recommendation: Adopt a Resolution allocating \$2 million from the General Fund in FY24 (July 1, 2023 through June 30, 2024) and FY25 (July 1, 2024 through June 30, 2025) that shall be invested in a grant program administered and coordinated by the Department of Health, Housing, and Community Services' (HHCS) Public Health Division (HHCS/PHD) consistent with the Sugar-Sweetened Beverage Product Panel of Experts (SSBPPE) Commission's goals to reduce the consumption of sugar sweetened beverages (SSB) in Berkeley and to address the health effects of SSB consumption. The total of \$2 million will be distributed in two installments of \$1 million per year for FY24 and FY25. The funds will be distributed as follows:

a. Direct the City Manager to award up to \$712,000 of the allocated funds to Berkeley Unified School District (BUSD) for the period, July 1, 2023 to June 30, 2025 through a grant proposal to reduce the consumption of sugar-sweetened beverages (SSBs) through the implementation and enhancement of the BUSD cooking and gardening programs. The BUSD funding process is separate from the RFP process for the general community-based organization funding process and shall be guided by the SSBPPE Commission's Criteria for BUSD Funding.

b. Direct the City Manager to award at least \$712,000 of the allocated funds for the period, July 1, 2023 to June 30, 2025 through an RFP process managed by HHCS/PHD for grants to community-based organizations consistent with the SSBPPE Commission's goals to reduce the consumption of SSBs and to address the effects of SSB consumption. The community-based organization funding RFP process is separate from the BUSD funding process and shall be guided by the SSBPPE Commission's Criteria for Community Agency Grants.

c. For the period, July 1, 2023 to June 30, 2025, direct the City Manager to allocate \$125,000 to fund Finance Department costs for staffing and MuniServices fees and \$451,000 to HHCS/PHD for staffing, operating and consulting costs to coordinate and monitor the grant process, manage resulting contracts awarded, support activities aligned with the goal of the sugary beverage tax, including the Healthy Retail Checkout ordinance, and provide an annual presentation to the SSBPPE Commission that includes process and outcome data and updates on Finance Department fees related to the sugary drink tax for the SSBPPE Commission to inform the development of the Commission's annual report.

d. Carryover any sugary drink tax revenue received in excess of \$2 million during FY24 and FY25 to be awarded for related services in FY25 – FY27.
