Dear Civic Arts Commission,

As a long-time Berkeley resident deeply engaged in the arts I have seen first hand the devastating impact that the COVID-19 pandemic has had on the vibrant and diverse arts and culture community that make Berkeley such a unique place to call home.

Berkeley's artists and cultural organizations have seen losses that in many cases are 90 to 100% of their annual revenue because of the pandemic and received small fractions of that in disaster assistance. The good news is that Berkeley is anticipated to receive $\sim $60,000,000$ in federal funding under the American Rescue Plan in May 2021 to help address issues like this.

I strongly support the Civic Arts Commission proposal to utilize a small fraction of that \$60MM (\$792,000) to restore full funding to the Arts Commission and fund the full planned slate of grants this year. Many of the dozens of of small arts and cultural organizations as well as individual artists in Berkeley are at the edge of financial precarity after a year of closures. It is critical that the full funding be restored using this windfall to the city rather than CUT funding by 21% as the base budget devoted by COVID proposes.

In addition, arts funding is an excellent investment that returns dollars to Berkeley. Money spent on the arts returns many fold to the city, with some estimates suggesting that every dollar in public arts funding leads to as much as \$20 in revenue through ticket sales, meals, entertainment, salaries, and the host of benefits that come with being a vibrant and desirable hub for culture.

In closing - please support full funding for Berkeley's Civic Arts Commission's \$792,000 supplemental request for support for Berkeley's hardest hit sector and keep Berkeley's role as a diverse and thriving cultural hub alive.

Subject: Budget and Civic Art Grants Funding

Mayor Arreguín and Council Members,

The Civic Arts Commission is inspired by the broad interest to increase funding for arts organizations in the current budget cycle. The Commission is encouraged by the thoughtful insights of Berkeley City Manager Dee Williams-Ridley's inclusion of an increased budget for the Civic Arts in Berkeley to \$2 million for the next fiscal year, and the Berkeley Cultural Trust's position for \$3 million in funding.

A great deal of analysis and investigation since our initial letter to you from April 28, 2021 has indicated that emerging from the pandemic will create an even greater burden on already-stressed arts organizations than initially thought. Research indicates that there is an increased need to fund onetime infrastructure such as HVAC systems, additional staffing, PPE and other equipment for arts organizations.

All indications are that arts organizations will require resources greater than prepandemic levels to safely open performance venues and galleries, and conduct safe and secure street festivals. Reopening, staffing and recapturing revenue from closures and reduced operations over the past 15 months will create an additional burden on these already-stressed organizations.

In order to assist artists and arts organizations and festivals to recover, the Civic Arts Commission is respectfully updating our request for consideration to the budget:

- Approval of the \$2 million recommended amount for arts organizations and individual artists as part of the City's Economic Recovery;
- An additional amount of up to \$1.25 million to be considered in funding in order to provide strong support for venues that have been shuttered for over 15 months;
- Providing funds as quickly as possible without requiring a new grants cycle (the distribution will be based on the Civic Arts Commission's recommended allocations to current grantees).

The Civic Arts Commission maintains its request from our April 28, 2021 letter for the following:

- Stabilizing the \$500,000 line item in the budget for the Civic Arts Grants for Individuals and Organizations;
- Increasing the annual funding for Civic Arts Grants for Festivals from the prepandemic level of \$158,315 to \$200,000, as they will now need annual additional funding to provide safety features for event attendees.

The Civic Arts Commission understands that this has been a unique budget cycle, and that the decisions before you are more demanding and urgent than ever, given the circumstances of this pandemic.
