

## City of Berkeley Health, Housing and Community Services Duplication of Benefits Certification for CARES Act Funds

The Coronavirus Aid, Relief, and Economic Security Act (Public Law 116-136)(CARES Act) provides that the Secretary shall ensure that there are adequate procedures in place to prevent any duplication of benefits as required by section 312 of the Robert T. Stafford Disaster Relief and Emergency Assistance Act (42 U.S.C. 5155), as amended by section 1210 of the Disaster Recovery Reform Act of 2018 (division D of Public Law 115 - 254; 132 Stat. 3442) and all applicable Federal Registers and notices.

The U.S. Department of Housing and Urban Development and the U.S. Department of Health & Human Services are requiring that each grantee have procedures to prevent the duplication of benefits when it provides financial assistance with Community Development Block Grant - Coronavirus funds (CDBG-CV), Emergency Solutions Grant – Coronavirus funds (ESG-CV), and Community Services Block Grant – Coronavirus funds (CSBG-CR).

A duplication of benefits occurs when a person, household, business, government, or other entity receives financial assistance and/or program service from multiple sources for the same purpose, and the total assistance received for that purpose is more than the total need for assistance (CDBG-CV FR-6218-N-0, and ESG-CV CPD Notice 20-08). Grant funds may not be used to pay for a cost if another source of financial assistance is available to pay for the same cost. Additionally, CSBG-CR funds require that subrecipients, assisted individuals or families, businesses, and other entities that receive CSBG-CR assistance have not previously received, or will not receive, duplicative assistance from another source before CSBG-CR assistance is provided (OMB Control No: 0970-0382 § 9.1).

This certification must be completed by all CDBG-CV, ESG-CV and CSBG-CR subrecipients. In consideration of acceptance of Cares Act Funding, the undersigned acknowledge and agree to the following:
