

## **Schedule for Data**

- Legacy Data issued by August 16 (not useful)
- Usable Legacy Data by August 23 (not final)
- Prison Population Adjustments
- Final Usable Date by September 23
  - IRC is prohibited by state law from posting a draft map until October 14
  - IRC use of data and mapping tool should follow the close of the public process, not precede or run concurrent

## **Types of Data**

- Point in Time Data (PL 94-171)
  - Total population, ethnicity, etc.
- Multi-Year Data
  - American Community Survey
  - More detail, more columns
  - Required to create Majority Minority District
- Shape Files (TIGER)
  - Map files with Census Blocks and Tracts

Subject: Public Submission Process Subcommittee

At the July 21, 2021, meeting, the Commisson voted to form a subcommittee for the public submission process. The purview of the subcommittee is the timeline, policies, procedures, and to support staff in the preparation of documentation for the public map submission process.

The public submission process is the next significant milestone in the redistricting process. The subcommittee will draft a timeline with exact dates for the public submission process to recommend to the Commission. The subcommittee will also draft policies and procedures to govern the submission of maps for the public.

With the release of the final census data in September, staff anticipates the public submission process will open in October. The subcommittee will need to make recommendations for the timeline and procedures surrounding the process prior to the opening of the public map submission period.

Commissioners Nicol and Choy have volunteered as members of the subcommittee. Staff recommends that one or two additional members be appointed to the subcommittee in order to increase the diversity of ideas and have more personal resources available to complete the documentation.

Subject: Independent Redistricting Commission Meeting Schedule

For regular business meetings of the commission, staff recommends Wednesday evenings at 6:00 p.m. For public hearings and/or special outreach meetings, the commission should consider varying the date and time in order to reach the broadest possible audience.

Staff recommends that the IRC hold its second public hearing in September. This meeting will launch the kick-off of the public map submission period and include a public Maptitude demonstration. The third public hearing should follow in mid-November for initial review of maps submitted by the public.
