Subject: Subcommittee Appointments to the Independent Redistricting Commission

At the December 15, 2021 regular meeting, the Commission made several changes to the membership of the ad hoc subcommittees. After reviewing these appointments and the history of the membership on the subcommittees with the City Attorney's Office, modifications are required in order to ensure compliance with the Brown Act.

Since none of the subcommittees have held any meetings since the December 15, 2021 meeting, there is not a concern about any potential Brown Act violations. Changes to the subcommittee membership may be made at the special meeting in accordance with the information below.

Map & Community of Interest (COI) Subcommittee

The original four members of the subcommittee were Commissioners Watson, Tran, Rhodes, and Copper. Commissioners Sussell and Nicol were subsequently added for a total membership of six (less than the Commission quorum of seven).

On December 15, Commissioners Watson, Cooper, and Nicol stepped off the subcommittee and Commissioners Choy and Alejos were added. This creates a concern due to the ongoing subject matter work of the commission and the total number of commissioners to serve on the subcommittee (8) exceeding a quorum of seven.

Due to these concerns, Commissioners Choy and Alejos may not serve on the Map & COI Subcommittee and only the previous six members are eligible to serve.

Report Drafting Subcommittee

The six members appointed on December 15 were Commissioners Watson, Gallegos-Diaz, Nicol, Cho, Choy, and Smith. Since this is a newly formed subcommittee that has not met, changes to membership are permitted. As noted at the meeting, Commissioners Choy, Cho, and Gallegos-Diaz have been meeting independently to review submitted maps and COI forms. The fact that all three members are on the Report Drafting subcommittee does not create a concern under the Brown Act because three members does not constitute a quorum of the subcommittee and the open meetings rules do not apply to ad hoc subcommittees. However, any change to the membership of the Report Drafting subcommittee would need to be carefully considered given the independent work of these three commissioners.

Communication Between Subcommittees

Communication between members of separate existing subcommittees about the work of those subcommittees risks violating the serial meetings rules of the Brown Act and should not occur outside of a public meeting of the full Independent Redistricting Commission. All Commissioners are expected to adhere to the Brown Act, the Bylaws, and the City Charter. Any failure to adhere to the rules can be cause for removal from the Commission pursuant to City Charter Section 9.5(e).
