- 1. Measure FF Monthly Report
  - a. Budget Overview No Update
    - i. Program Review
      - **1. Standards of Coverage Analysis** The Department is undergoing an indepth analysis of fixed and mobile resources to determine the best

deployment model and to ensure the Department is responding effectively and efficiently.

- Status: Following the presentation to the City Council on April 19<sup>th</sup>, the Department is working to determine how to fund the one major recommendation that has not already been planned and funded, a resource to handle low acuity EMS calls for service.
- 2. **Project Management and Subject Matter Expert (SME)** Through this contract, the Department has relied on a team of professionals that have varied background including in project management, information technology, videography, marketing and industry specialists that have specific skills in emergency medical service and training.
  - a. Status: The project management team has been helping us find and transition to a project management platform and has been providing Subject Matter Expert (SME) assistance for a variety of projects.
- 3. Community Wildfire Protection Plan (CWPP) The CWPP is a comprehensive risk analysis that addresses local target hazards and includes a community-based action plan to mitigate threats, promote preparedness activities, and ensure resiliency. It will serve as the foundation and roadmap for the Departments work to prevent wildfire and limit the spread when they ignite.
  - a. Update: The core team was selected and met on May 13<sup>th</sup>. The project is estimated to take nine months to complete.
- 4. Wildfire Prevention / Mitigation Vegetation Management Inspections See chart below.
- 5. Retired Annuitants The retired annuitants are largely focused on performing vegetation inspections for properties in fire zone 2 and 3. They are also looking at transitioning the inspection from paper to mobile technology, re-tooling the re-inspection, citation, and violation process. The Department has also expanded its traditional hazardous fire area program to include all properties in fire zones 2 and 3.
- Update: As the Department nears the point where it will be adding permanent staff to the Division, it will be working with HR and the CAO to determine how and if the retired annuitants can stay on board.
- 6. Emergency Medical Technician (EMT) and Paramedic Recruitment Single Function Job Classifications & Recruitment:

- a. The Division has worked collaboratively with Local 1227 and Human Resources to draft single function EMT and Paramedic Job Classifications which were approved with elation at the December Personnel Board meeting and were approved by the City Council on January 18th, 2022.
  - i. Update: We are nearing the time when we will begin recruitment for both of these classifications. The hiring process will take approximately 3-6 months, then they will participate in an eight week academy and then they will begin their field training time.
- 7. Fire Facilities Master Plan (FMP): Berkeley Fire Department stations are undersized, in poor condition and in need of remodels or replacement. The Department initiated a long-term replacement planning process to better understand infrastructure needs. This process will provide the City leaders of today and tomorrow with actionable information ahead of future infrastructure bond measures.
  - i. Update: The team is working through the data analysis and planning process and will deliver a midproject report to the City Council in late July.
- 8. Dispatch Study: Our goal, per Council direction is to enhance the dispatch center so it can triage calls, divert non-emergency calls (including mental health calls) to appropriate resources like the SCU; and provide emergency medical instructions to callers.
  - Status: The study continues and we project that we will have the final report completed in August of this year.

#### 9. Recruitments:

- a. Shift Fire Inspector Recruitment –These are filled by existing fire department personnel and are used to assist with fire investigations and other inspection related activities in the built environment.
  - i. Update: In-service training is scheduled for July.
- b. Sworn Fire Inspector Recruitment Recruitment is on-going.
  - i. Update: We plan to promote an additional three inspectors sometime in 2022, when staffing permits.
- 10. Division of Training Property The Department is actively engaged to find a piece of property that will meet the City's needs for the training and development of its emergency responders and support staff. Due to zoning, the cost of property and the proximity of residential units to most property in Berkeley, this location will likely be outside the City

proper. This presents exciting opportunities for regional collaboration with other fire departments and a community college district.

- a. Update: We are moving forward with lease negotiations for a property in Richmond and we are also engaged in discussions with departments throughout Alameda and Contra Costa with regard to creating a training consortium.
- ii. Implementation & Metrics
  - Outdoor Warning System –We are still facilitating the permit process between the COB and vendor. We have also started planning the permitting process with the State Department of Architecture which is the permitting authority for the school district.

Re: Red Curb and Visible Signage

#### Recommendation

The Disaster and Fire Safety Commission ("Commission" or "DFSC") respectfully requests that the City Manager take the following actions in preparation for what could be a historic drought and fire season:

- 1. Fix, update, and confirm all parking restriction signage around districts 2 and 3;
- 2. Red curb all fire hydrant areas to the maximum allowable by law;
- 3. Direct the Fire Department and public works to identify areas that could be pinch points for fire trucks to travel and red curb

The Commission would like to continue enforcement of existing code and processes. In this case, the Commission believes that is important for all city residents to understand restrictions (items 1 & 2). And with item 3, understand the importance of not impinging on fire hydrants and allowing for the Fire Department to execute their duties most effectively in case of fire and other emergencies.

#### FISCAL IMPACTS OF RECOMMENDATION

The Commission is not privy to the budget from Public Works and other departments but it could be part of an existing planned update / rollout. With the increasing fire danger, we ask that Public Works and related departments move forward expenditures which may already be in the works. Red curbing around fire hydrants may be a cost that could be borne out using FF funds.

# **BACKGROUND**

The City signage in the hills is in various states of disrepair. Without clear signage, there is a tendency for residents to ignore signage and park in prohibited areas. Parking in restricted areas could result in blocking fire trucks' ability to get to an emergency and could prevent residents from egress should there be a hillside fire. While there is existing law that governs parking near hydrants, that tends to be ignored. Without ongoing sustained parking enforcement, the Commission

believes it can not change existing culture. As such, red curbing to the maximum extent of the law could serve as a reminder of parking restriction and allow for the fire department to access hydrants in case of fire. Lastly, we ask for further interdepartmental discussions around pinch points for fire trucks where red curbing those pinch points would allow for fire trucks access in case of emergencies. In cases where there is no sidewalk, the edge of the asphalt could be painted to serve the same purpose.

#### **ENVIRONMENTAL SUSTAINABILITY**

There is no direct environmental impact of this recommendation.

#### **RATIONALE FOR RECOMMENDATION**

The rationale is to prepare for the possibility for fire and other emergencies, allow for ingress of Fire Department personnel, and prepare the community for a larger discussion around Safe Passages (ingress and egress in case of emergencies).

#### ALTERNATIVE ACTIONS CONSIDERED

There is no alternative to existing signage other than a delayed expenditure of existing infrastructure. Not red curbing the areas around the fire hydrants and focusing on parking enforcement is another possible approach, but would require severely increased parking enforcement which is yet to be approved. There are no alternatives to identifying pinch points that would effectively allow for Fire Department ingress in all instances..
