Late Communication 1 Planning Commission December 5, 2018 eliminating racism empowering women **VACCA** berkeley / oakland

Dear Planning Commission,

Although I am aware that everybody on the Planning Commission are most likely knowledgeable of the unfeasible prices and anxiety-inducing struggles UC Berkeley students face in the housing crisis, I am here to serve as a reminder of these shocking statistics as a call to action for everyone on this commission to keep working towards affordable housing. I am a first year student who joined the advocacy group at YWCA Berkeley/Oakland because I was inspired by their mission; "dedicated to eliminating racism, empowering women, developing leaders and promoting peace, justice, freedom and dignity for <u>all</u>."

How can one define justice in this housing crisis? I can tell you what is not just. It is not just that a two-bedroom apartment in Berkeley is \$2,810, which compared to the national average, \$1,150 is strikingly higher. It is not just to expect full time students to pay for an apartment that requires a full time worker, for example, graduate students at Berkeley have to pay 50% of their income per month on rent. It is not just that you must apply for the Berkeley Student Cooperatives more than a year in advance just to be placed on a long waiting list. It is not just that "students make up approximately half of the renters in Berkeley...and are often unaware of their rights because they are typically first time tenants." Students should not be taken advantage of, and they should not be made to conform to think that these living conditions and prices are fair because they are not.

UC Berkeley always boasts about being the #1 Public University but never boasts about the fact that they only house 22% of undergraduates and 9% of graduates, compared to the UC average of 38.1% for undergraduates and 19.6% for graduates. I, like everyone at UC Berkeley, studied vigorously and want to continue working hard towards a higher education, housing should not be the obstacle that prevents the desire for education and the willingness to work for it.

Lastly, an article written by DailyCal earlier this year reminds the Planning Commission of the students bombarding their office advocating for the More Student Housing Now resolution, and it hold the Planning Commission accountable for cancelling 50% of their meetings in 2016 and 38% of their meetings in 2017. It is one thing to call yourself a planning commission but is another to actively plan and act on the needs of the students.

I urge you to join the YWCA in continuing to advocate for affordable housing, leaders need housing to develop, and it is not dignified to idly watch a student dig themselves into debt for a small, unlivable space. And ultimately, do not take these facts with a grain of salt, real students are affected by this problem every day and it is our duty to alleviate this issue as human beings.

SUBJECT: Public Hearing: Cannabis Retail Nursery Microbusiness Ordinance **Considerations and Analysis**

1. Appropriate Location. Currently, Berkeley permits cannabis retail sales in commercial districts and cultivation in the M district. These regulations would allow limited cultivation and retail sales at sites already used for plant cultivation and sales. The existing nurseries identified by staff are located either in manufacturing, commercial and residential districts (see Attachment 5 for map). Conversion of sites either partially or entirely located in residential districts to an RNM use would be considered at a public hearing as part of a Use Permit for a change to a nonconforming use. Agree, maintains ability for residential cannabis nurseries 3. Uses on site. Uses at a RNM would be limited to cultivation of seeds and immature plants, distribution of these products to other cannabis businesses, and retail sales of these products. No manufacturing or sales of other cannabis products would be permitted at the site. Disagree, shared nursery and manufacturing locations provides less competition for limited available permitted zoning sites (between cannabis and non cannabis business'), certainly a WEIBAC friendly consideration 4. Expansion of a non-conforming use. Based on the Zoning Ordinance, the addition of cannabis production or sales would be considered a change in use to a conventional nursery. If the nursery is non-conforming due to its location in a Residential district, this change would require a Use Permit in order to be approved. Agree, and recommend- residential use appropriate for following reasons: low neighborhood impact; again, expanded permit area decreases competition for currently limited permitted zones; present qualified nursery candidate owning long time nursery site in residential zone
