### 9. Discussion: Citywide Affordable Housing Requirements Update

Staff consultant Rick Jacobus of Street Level Advisors provide an overview of existing affordable housing requirements and how they impact the generation of affordable housing units and funds. The consultant also shared several policy options to consolidate existing affordable housing requirements that incorporates inclusionary housing, the affordable housing mitigation fee, condo conversions, and the live/work provisions.
