Subject: Proclamation in Recognition of Fabulous Activist Bay Area Lesbians with Disabilities: A Storytelling Project

#### RECOMMENDATION

Adopt the Berkeley Lesbians with Disabilities proclamation as a sign of support and appreciation for local disabled lesbian women.

#### BACKGROUND

For the past forty years, San Francisco Bay Area lesbians with disabilities have been actively engaged in political, social, and cultural waves of change. These women have successfully fought for the Americans with Disabilities Act, that now-integral part of U.S. law, as well as other programs with equal rates of success. However, as a subgroup of the disabled American population, activist lesbians with disabilities still remain an undocumented minority, whose contributions are in danger of being forgotten.

Thankfully, the group Fabled Asp (Fabulous Activist Bay Area Lesbians with Disabilities: A Storytelling Project) seeks to archive and document the contributions that lesbians with disabilities have made to society. A multicultural, multiracial, multimedia project whose members encompass four generations of disabled lesbians, Fabled Asp has utilized such mediums as theater, film, readings, quilts, dance performances, and audio in their efforts to ensure history and recognition of the contributions made to American society by lesbians with disabilities.

In recognition of the forty years of activism in politics and culture in the Bay Area that lesbians with disabilities have done for our community and society, a proclamation is recommended to be adopted to celebrate the lives of lesbians with disabilities and honor the efforts both the disabled lesbian population have contributed towards society and the efforts Fabled Asp has made to document these contributions.
