Subject: Amendment: FY 2013 Annual Appropriations Ordinance

RECOMMENDATION

Adopt first reading of an Ordinance amending the FY 2013 Annual Appropriations Ordinance No. 7,254–N.S. for fiscal year 2013 based upon recommended re-appropriation of committed FY 2012 funding and other adjustments authorized since July 1, 2012, in the amount of \$59,102,317 (gross) and \$52,866,832 (net).

FISCAL IMPACTS OF RECOMMENDATION

On June 26, 2012 the City Council adopted the FY 2013 Budget, authorizing gross appropriations of \$364,920,134 and net appropriations of \$313,563,163 (net of dual appropriations).

This first amendment to the Annual Appropriations Ordinance totals \$59,102,317 (gross) and \$52,866,832 (net), increasing the gross appropriations to \$424,022,451 and net appropriations to \$366,429,965 and largely represents the re-authorization of funding previously committed in FY 2012. The recommendations in this report include most City operating and grant funds and are largely attributed to capital projects:

1. Encumbered contract obligations from FY 2012 totaling \$34,634,183;
2. Recommendations to re-appropriate committed, unencumbered FY 2012 funding for all funds in the amount of \$16,532,457; and
3. Changes to fund appropriations primarily due to receipt of new grants and use of available fund balances in the amount of \$7,935,677.

The changes to the General Fund total \$3,244,965, which includes encumbrances of \$2,269,021, unencumbered carry-over requests of \$775,329, and adjustments of \$200,615. The Capital Improvement Fund changes total \$5,949,516 and includes encumbrances of \$1,725,836 unencumbered carry-over requests of \$3,377,606 and adjustments of \$846,074.

BACKGROUND

The Annual Appropriations Ordinance (AAO) establishes the expenditure limits by fund for FY 2013. Throughout the year, the City takes actions that amend the adopted budget. These may include, but are not limited to, the acceptance of new grants,

revisions to existing grants, and adjustments to adopted expenditure authority due to emergency needs.

The adopted budget is also amended annually to reflect the re-appropriation of prior year funds for contractual commitments (i.e. encumbrances) as well as unencumbered carryover of unexpended funds previously authorized for one-time, non-recurring purposes. These budget modifications are periodically presented to the Council in the form of an Ordinance amending the Annual Appropriations Ordinance, which formally requires a two-thirds vote of the City Council. This report primarily addresses re-appropriating FY 2012 spending authority to FY 2013 of available cash for commitments entered into in prior years and is the first amendment to the FY 2013 AAO.

When Council adopts an appropriations ordinance (budget), it is based on projected revenues and expenditures. If revenues do not support the adopted level of expenditures then the adopted appropriations levels cannot be supported. If fund balances do not support the requested level of expenditures, no carryover is recommended.

The proposed changes, presented in their entirety in Exhibit A, are summarized as follows:

Carryover Process

Departments were asked to submit detailed information regarding the reasons for the unencumbered carryover requests to assist staff in determining which funds should be carried into FY 2013. In prior years, funds have been approved for carryover from one year to the next based on funding availability. This practice is consistent with a policy whereby funds approved for a particular program or project remains continually appropriated until expended, or completion of the project.

Given the significant program and staff reductions implemented in the last few years, requests for carryover were critically reviewed. This report recommends \$16.5 million in unencumbered carryover for Council review and approval, representing funding only for critical projects and programs.

Types of Carryover

FY 2012 Encumbrance Rollovers, totaling \$34,634,183 reflect contractual obligations entered into in fiscal year 2012 which had not been paid as of June 30, 2012. Funding for these "encumbered" commitments is brought forward into the current fiscal year to provide for subsequent payment of these obligations. The FY 2013 Adjusted Budget currently includes the carry forward of FY 2012 encumbrances.

FY 2012 Unencumbered Carryover, totals \$16,532,457 and reflects the carryover of funding authorized by the City Council for specific purposes that had not been

expended by year-end. The carryover for the General Fund includes many non-discretionary funding allocations and represents around 5% of the total recommended unencumbered carryover amount. Capital Improvement Funds carryovers are for continuing projects and makes up 20% of the unencumbered carryover. The remaining 75% represents carryover items in non-discretionary funds.

FY 2013 Other Adjustments total \$7,935,677 and reflect actions taken by the City Council since adoption of the FY 2013 budget as well as adjustments required since budget adoption. Many of these adjustments are within non-discretionary funds and reflect the appropriation of grant funding and the use of available fund balance.

Below is a summary of the FY 2012 Unencumbered Carryover and the FY 2013 Adjustments for the City's General Fund and Other Funds.

General Fund

The General Fund includes unencumbered carry-over requests of \$775,329 and other adjustments of \$200,615 including the following program allocations:

- ❑ \$265,076 for November 2012 election costs
- ❑ \$133,729 for the Public Safety System project
- ❑ \$54,634 for Council Office budgets
- ❑ \$43,499 for Customer Service software upgrades and call accounting software

- ❑ \$169,000 in funds received from the State of California for assistance with electronic record keeping

Other Funds

Other City funds (including capital improvement project funds) total unencumbered carryover of \$15,757,128 and other adjustments of \$7,735,062 including the following project allocations:

- ❑ \$2,667,816 in HUD-HOME funds for Housing Trust Fund Projects
- ❑ \$594,806 in CDBG funds for Section 108 loan repayment, James Kenney Recreation Center Improvement Project, Housing Trust Fund loans, Senior Center kitchen improvements, and Senior Rehabilitation loans
- ❑ \$3,377,606 in Capital Improvement Projects funding for Housing Trust Fund loans, the Voiceover Internet project, parks projects, storm water repairs, and street rehabilitation projects
- ❑ \$2,009,664 in Metropolitan Transportation Grant funds for the Bay Trail Extension project and several Public Works Transportation projects
- ❑ \$804,887 in CALTRANS Grant Funds for the Berkeley Transportation Action Plan – Parking Management project and the Caldecott Tunnel 4th Bore Settlement projects
- ❑ \$1,014,399 in Measure WW funds for approved park projects

- ❑ \$712,337 in CALTRANS Safe Routes to School Grant Funds for the Safe Routes to School project
- ❑ \$534,450 in Clean Storm Water Funds for storm water projects in progress

- ❑ \$375,000 for the establishment of the Berkeley Tourism Business Improvement District (BID) Fund. This 1 percent self assessment supports tourism marketing and sales promotion for Berkeley hotels.

RATIONALE FOR RECOMMENDATION

The recommendation allows the City to amend the FY 2013 Adopted Budget, re-appropriating funds from FY 2012 to FY 2013 for contractual commitments that need to be paid and revising the budget to reflect approved carryover requests in both discretionary and non-discretionary funds.

The recommendations in this report deal with the unencumbered carryover in the funds listed above and the other adjustments in all funds. Staff has conducted a detailed analysis of the individual carryover requests submitted by departments and is presenting carryover recommendations for projects that are either currently under contract, represent council priorities, and/or are considered critical.

Section 3. Copies of this Ordinance shall be posted for two days prior to adoption in the display case located near the walkway in front of Old City Hall, 2134 Martin Luther King Jr. Way. Within 15 days of adoption, copies of this Ordinance shall be filed at each branch of the Berkeley Public Library and the title shall be published in a newspaper of general circulation.
