Subject: Redistricting Referendum Petition: Repeal Ordinance No. 7,320; and Adopt the First Reading of an Ordinance to Amend City Council District Boundaries from the United Student District Amendment

### RECOMMENDATION

1. Adopt an Ordinance rescinding in its entirety Ordinance No. 7,320 N.S. "Authorizing the Adjustment of Berkeley City Council District Boundaries Pursuant to Section 9, Article V of the Berkeley City Charter, to Equalize Population in the Districts as a Result of Population Changes Reflected in the 2010 Decennial Federal Census.", adopted by the Berkeley City Council on December 17, 2013; AND
2. Adopt first reading or a statement of intent to adopt an Ordinance created from the United Student District Amendment Plan adjusting the City Council district boundaries pursuant to Section 9, Article V of the Berkeley City Charter, to equalize population in the districts as a result of population changes reflected in the 2010 Decennial Federal Census (Attachment 2)

### FINANCIAL IMPLICATIONS

Rescinding Ordinance No. 7,320 in response to the referendum petition would save potentially hundreds of thousands of dollars in attorney's fees and costs associated with placing a ballot measure on the November 4, 2014 Statewide Election. Adopting the USDA would also save tens of thousands of dollars of staffing time.

### BACKGROUND

Under Elections Code Section 9241, if the Council rescinds the ordinance that was the subject of the referendum, it cannot adopt the same ordinance for a period of one year.

If a new ordinance is adopted, under case law it must be "*substantially different*" from the legislation that was rescinded. In re Stratham (1920) 45 Cal.App. 436, 187 P.986 the court concluded: "*when an ordinance which has been suspended by a referendum has been repealed by [a municipal] council, the council cannot enact another ordinance in all essential features like the repealed ordinance .... The council may, however, deal further with the subject matter of the suspended ordinance, by enacting an ordinance essentially different from the ordinance protested against, avoiding, perhaps, the objections made to the first ordinance. If this be done, not in bad faith, and not with*

*intent to evade the effect of the referendum petition, the second ordinance should not be held invalid for this cause.”*

Subsequent to this decision several courts have followed or endorsed this “Stratham” rule. In Assembly supra 30 Cal.3d at pp 644-645. 180 Cal.Rptr. 297, 639 P 2d 939, the court stated, *“Since its inception, the right of the people to express their collective will through the power of the referendum has been vigilantly protected by the courts. Thus, it has been held that legislative bodies cannot nullify this power by voting to enact a law identical to a recently rejected referendum measure.”*

Consistent with case law if a new redistricting ordinance is to be adopted it must be “substantially different” from the rescinded ordinance, must not be acted upon in “bad faith, and should respond to the issues raised in the referendum petition. All the referendum petitions explicitly raised the following issues:

*“We the undersigned voters of the City of Berkeley protest against the passage of Ordinance No. 7,320-N.S., which adopts the controversial City Council redistricting plan which divides neighborhoods and disenfranchises students, neighborhoods and progressives from having an equitable say in electing their city leaders.”*

Some of the specific details repeatedly mentioned by circulators included: 1) the adopted redistricting plan kicked out the majority of Berkeley Student Cooperative houses that were already in the current student district, by removing the Northside blocks from District 7; 2) the adopted plan failed to include a majority of dorms, even though 9 out of 12 dorms are in sufficiently close proximity to easily be included. 3) it needlessly divided neighborhoods throughout Berkeley that did not need to be divided, and failed to respond to the concerns expressed by dozens of neighborhoods in the Berkeley Neighborhood Council. 4) the adopted plan was widely perceived as politically punitive to the chances of a progressive candidate and some described it as a partisan gerrymander.

Therefore any alternative redistricting plan should include the Northside blocks in District 7 and unite neighborhoods that are divided as much as possible.

The United Student District Amendment (USDA), which was the last alternative map the Council considered, united some additional neighborhoods and also included the Northside blocks in District 7. USDA had an equal population deviation per Council District of less than 1%, and uses the following Major Streets and Collector Streets in its boundaries: Sacramento Street, Cedar Street, Spruce Street, Shattuck Avenue, Oxford Street, Hearst Avenue, Bancroft Way, Fulton Street, Centennial Drive, Dwight Way, Telegraph Avenue, Ashby Avenue, University Avenue, Martin Luther King Jr. Way, and Milvia Street. Given that USDA not only complies with Charter requirements, but directly addresses the issues raised in the referendum petition, the Council could consider adopting a first reading of an ordinance approving USDA’s district boundaries.

ORDINANCE NO. ##,###-N.S.

REPEALING ORDINANCE NO. 7,320-N.S., AUTHORIZING THE ADJUSTMENT OF BERKELEY CITY COUNCIL DISTRICT BOUNDARIES PURSUANT TO SECTION 9, ARTICLE V OF THE BERKELEY CITY CHARTER, TO EQUALIZE POPULATION IN THE DISTRICTS AS A RESULT OF POPULATION CHANGES REFLECTED IN THE 2010 DECENNIAL FEDERAL CENSUS

BE IT ORDAINED by the Council of the City of Berkeley as follows:

Section 1. Repeal

In accordance with Berkeley City Charter Article XIV, Section 93, Ordinance Number 7,320-N.S., which adjusted City Council District boundaries beginning with the November 2014 election is hereby repealed in light of the referendum measure protesting the passage of such ordinance which has qualified for placement of such referendum on the ballot.

Section 2. Posting.

Copies of this Ordinance shall be posted for two days prior to adoption in the display case located near the walkway in front of Old City Hall, 2134 Martin Luther King Jr. Way. Within fifteen days of adoption, copies of this Ordinance shall be filed at each branch of the Berkeley Public Library and the title shall be published in a newspaper of general circulation.

AUTHORIZING THE ADJUSTMENT OF BERKELEY CITY COUNCIL DISTRICT BOUNDARIES PURSUANT TO SECTION 9, ARTICLE V OF THE BERKELEY CITY CHARTER, TO EQUALIZE POPULATION IN THE DISTRICTS AS A RESULT OF POPULATION CHANGES REFLECTED IN THE 2010 DECENNIAL FEDERAL CENSUS

BE IT ORDAINED by the Council of the City of Berkeley as follows:

Section 1. Purpose.

In order that the eight City Council Districts shall continue to be nearly equal in population as may be according to said 2010 Decennial Federal Census, the City Council Districts are hereby adjusted as set forth in Section 2.

Section 2. District Boundaries.

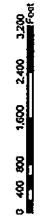
The district boundaries established herein shall govern the election of Councilmembers beginning with the November 4, 2014 General Municipal Election.
