SUBJECT: Letter of Support for Assembly Bill 1014

RECOMMENDATION:

Send a letter of support of Assembly Bill 1014 to Assemblymember Nancy Skinner.

BACKGROUND:

Family members and people close to us often see the warning signs when individuals are a danger to themselves or others. In some cases, however, existing state law does not provide a mechanism to limit the loved one's access to firearms while help or treatment (i.e. mental health counseling, substance abuse treatment, or anger management) is sought. The recent shootings in Santa Barbara after the parents of the disturbed young man desperately tried but failed to get help before their son's killing spree, are a tragic example of why families in crisis need more legal options.

AB 1014, modeled on our state's domestic violence restraining order laws, provides family members and law enforcement with important new legal tools. Similar to existing laws in Connecticut, Indiana, and Texas, AB 1014 allows for the removal of firearms from individuals who are at risk for committing acts of violence. It establishes a process for obtaining a Gun Violence Restraining Order (GVRO) from a court in order to *temporarily* limit (for one year, unless renewed) the individual's access to firearms when there are warning signs or indications that the person is at risk for violence.
