RECOMMENDATION

Adopt a Resolution confirming the results of the March 7, 2017 Special Municipal Election for City Council District 4.

FISCAL IMPACTS OF RECOMMENDATION

CURRENT SITUATION AND ITS EFFECTS

The Alameda County Registrar of Voters has submitted to the City Clerk the official Statement of Votes cast for the City of Berkeley Special Municipal Election held on March 7, 2017 and the City Clerk has prepared the attached Certification of Election Results.

The attached Resolution confirms the results of the March 7, 2017 Election and declares the candidate elected to the office of City Council District 4.

BACKGROUND

The City conducted its General Municipal Election on November 8, 2016 at which time then-Councilmember Jesse Arreguin was elected to the office of Mayor, creating a vacancy in the office of City Council District 4. In accordance with the City Charter (Article V, Section 12), the City Council called for a special election at its December 8, 2016 meeting to fill the vacancy.

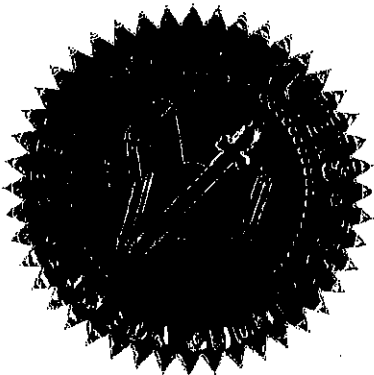
