BACKGROUND

We are proposing that the City Council make a grant of \$50 to the Luna Dance Institute, for their 30<sup>th</sup> Anniversary Gala on March 18, 2017. Luna Dance proudly celebrates 25-years of bringing children to dance and dance to all children. Luna Dance Institute and our model program—School & Community Alliances (SCA), work in tandem to bring high quality dance learning to all children. Luna’s pedagogy drives all programs through professional education for dance teaching artists, classroom teachers, school and arts leaders, early childhood education faculty and social workers, we help build cultures of dance, particularly for those underserved.

AUTHORIZING THE EXPENDITURE OF SURPLUS FUNDS FROM THE OFFICE EXPENSE ACCOUNTS OF THE MAYOR AND COUNCILMEMBERS FOR A GRANT TO PROVIDE PUBLIC SERVICES FOR A MUNICIPAL PUBLIC PURPOSE

WHEREAS, Councilmember Cheryl Davila has surplus funds in her office expenditure account (budget code 010-0224-410); and

WHEREAS, a California non-profit tax-exempt corporation Luna Dance Institute seeks funds in the amount of \$50 for their 25-year Anniversary Gala fundraiser, on March 18, 2017, toward raising funds to provide dance to all children; and

WHEREAS, Luna proudly celebrates 25-years of service to the community, providing access to dance to underserved children and families; and

WHEREAS, the provision of such services would fulfill the following municipal public purpose: serving the cultural and social needs fulfilled through integrated dance programming.
