 Subject: Contract No. 10217 Amendment: TranSystems, Inc. for Design Revisions and Construction Support Services for the South Cove Parking Lot and Restroom Project

RECOMMENDATION

Adopt a Resolution authorizing the City Manager or her designee to execute an amendment to Contract No. 10217 with TranSystems, Inc. adding \$25,300 for design revisions and construction support services for the South Cove Parking Lot and Restroom Project for a total contract amount not to exceed \$193,271.

FISCAL IMPACTS OF RECOMMENDATION

Funds for this amendment in the amount of \$25,300 for a total contract amount not to exceed \$193,271 are available from the National Fish and Wildlife Foundation Cosco Busan grant budget code 421-5950-450.30.35-12WF01. These funds will be appropriated as part of the second amendment to the FY 2017 Annual Appropriations Ordinance. CMS No. BCPLN.

CURRENT SITUATION AND ITS EFFECTS

The South Cove Parking Lot and Restroom Project at the Berkeley Marina was advertised for bids on November 7, 2016 and received two bids on December 6, 2016. The low bid of \$1,818,000 for construction exceeded the design engineer's estimate of \$1,430,000 by 27%. The current grant funding for this project totals \$1,600,000 and must cover both the construction bid costs as well as the construction administration costs, which is an additional cost of approximately 10%. Based on the bids received, the project was unable to proceed, and on January 24, 2017, the City Council authorized the City Manager to reject the bids and direct staff to re-scope and re-advertise the work associated with the South Cove Parking Lot and Restroom Project (Resolution No. 67,813). In order to complete this work, additional design revisions and construction support services are required from the designer, Transystems Corporation. The Accessible Gangway Project will be bid separately from the South Cove Parking Lot and Restroom Project the summer of 2017.

BACKGROUND

On July 10, 2012, after staff conducted a competitive process for design and construction support services for the South Cove Improvement Project at the Berkeley Marina (Spec No. 12-10652-C), Council authorized Contract No. 9076 with TranSystems, Inc. in the amount of \$139,625 (Resolution No. 65,809-N.S.) using grant funding from the California Department of Boating and Waterways. The scope of the contract included design services, permit consultation, and construction support services during the construction phase.

On September 10, 2013, Council authorized an amendment to Contract No. 9076 to add an additional \$43,260 to upgrade the design of the new restroom and associated utilities and storm drainage system for a new total not to exceed \$182,625 (Resolution No. 66,300-N.S.)

On February 24, 2015, Council authorized funding for final design services and construction support services to Transystems during the construction phase of the project in an amount not to exceed \$75,955 (Resolution No. 66,931). For administrative purposes, the contract number was changed to 10217.

On May 31, 2016, Council authorized funding for additional design services and construction support services needed as the result of permit review comments to Transystems adding \$29,016 for the South Cove Parking Lot and Restroom Project for a total contract amount not to exceed \$104,971 (Resolution No. 67,510).

On March 14, 2017, Council authorized funding for additional design services and construction support services needed as the result of permit review comments to Transystems adding \$63,000 for the South Cove Parking Lot and Restroom Project for a total contract amount not to exceed \$167,971 (Resolution No. 67,858).

ENVIRONMENTAL SUSTAINABILITY

A newly-improved paved East parking lot at the South Cove will divert stormwater into the new bioswale where it will be cleansed of any pollutants before it drains to the Bay.

RATIONALE FOR RECOMMENDATION

Additional design and construction support services are needed to re-scope the project so that the project can be accomplished with project funding that is currently available.

CONTRACT NO. 10217 AMENDMENT: TRANSYSTEMS, INC. FOR SOUTH COVE
PARKING LOT AND RESTROOM PROJECT

WHEREAS, on March 14, 2017, Council authorized funding for additional design services and construction support services needed as the result of on permit review comments to Transystems, adding \$63,000 for the South Cove Parking Lot and Restroom Project for a total contract amount not to exceed \$167,971 (Resolution No. 67,858); and

WHEREAS, funds for this amendment in the amount of \$25,300 for a total contract amount not to exceed \$193,271 are available from the National Fish and Wildlife Foundation Cosco Busan grant budget code 421-5950-450.30.35-12WF01. These funds will be appropriated as part of the second amendment to the FY 2017 Annual Appropriations Ordinance. CMS No. BCPLN.

NOW THEREFORE, BE IT RESOLVED by the Council of the City of Berkeley that the City Manager or her designee is hereby authorized to execute a contract amendment for Contract No. 10217 with TranSystems, Inc. adding \$25,300 for design revisions and construction support services for the South Cove Parking Lot and Restroom Project for a total contract amount not to exceed \$193,271.
