### RECOMMENDATION

Adopt a Resolution declaring the Council of the City of Berkeley opposes fascism, white supremacy, anti-Semitism, and any individuals or organizations [promoting fascism](#) and/or committing violent attacks on people in Berkeley or anywhere else. Request City Clerk to send copies of this resolution to Senator Dianne Feinstein, Senator Kamala Harris, and Representative Barbara Lee.

### FISCAL IMPACTS OF RECOMMENDATION

### CURRENT SITUATION AND ITS EFFECTS

We live in a climate of increased surveillance, militarization of the police, and the threat of an actual police state under martial law due to the signing of the fascist tool, the 2012 NDAA (National Defense Authorization Act), which can now be used by the current President. The 2012 NDAA enables any President to point a finger of suspicion and accusation, with no evidence, at anyone, and have them arrested, not by the sheriff, but by the military, and have them disappear with no acknowledgement that they were taken and subject them to indefinite detention, while denying them the right to trial or counsel. Berkeley has been targeted this year by fascist groups physically and psychologically confronting people on our streets and in our parks with propaganda and violence.

At the September 11, 2017 meeting of the Peace and Justice Commission, the Commission approved the following motion:

### BACKGROUND

There has been a xenophobic atmosphere of hate and hate crimes across the country in recent times, including physical attacks on people and including murders by members and followers of organized right wing and fascist organizations.

One example of those hate crimes was the murder of two men in Portland, Oregon on May 26, 2017, after they came to the aid of two women who were being harassed because they appeared to be Muslim.

Other examples of such recent hate crimes are the murder of Heather Heyer and the injuring of others by white supremacists and neo-Nazis in Charlottesville, Virginia on August 12, 2017.

Furthermore, the current administration has targeted vulnerable population groups throughout the United States, overseeing a rise in deportation and discriminatory policies.

### RATIONALE FOR RECOMMENDATION

This recommendation and resolution is consistent with the values of Berkeley and the mandate of the Peace and Justice Commission. DECLARING BERKELEY'S OPPOSITION TO FASCISM

WHEREAS, the Peace and Justice Commission advises the City Council on all matters relating to the City of Berkeley's role in issues of peace and social justice (Berkeley Municipal Code (BMC) Chapter 3.68.070); and

WHEREAS, the City of Berkeley and its residents have long stood for civil rights, human rights, civil liberties, peace, equality, and free speech; and

WHEREAS, the last time the United States issued a declaration of war, it fought a war against fascism; and

WHEREAS, citizens of Berkeley died with citizens of other places, fighting against fascism and in support of human rights; and
