Subject: Appoint Darryl Moore to the Berkeley Housing Authority Board

RECOMMENDATION

Adopt a Resolution appointing Darryl Moore to serve a four-year term on the Berkeley Housing Authority Board of Commissioners.

BACKGROUND

On May 22, 2007, the Berkeley City Council established a Berkeley Housing Authority (BHA) Board of Commissioners. State law mandates BHA commissioners, including successors be appointed by the Mayor and confirmed by the City Council.

Valerie Agostino, first appointed to the BHA Board in 2009 and re-appointed in 2016, resigned in the spring of 2018 leaving on vacancy on the BHA Board.

I am nominating Darryl Moore, former District 2 City Councilmember, and a Senior Management Analyst with the Oakland Housing Authority to serve on the BHA Board. While a City Councilmember, Mr. Moore served on the governing board of the Berkeley Housing Authority and oversaw the transition of BHA from the city to an independent agency. He served as a member of the 3x3 Committee of BHA and the City Council throughout his service on the Council and advised BHA during its transition out of troubled status and the disposition of 75 units of public housing. Professionally, through his work at the Oakland Housing Authority, Mr. Moore is knowledgeable about HUD regulations and the administration of public housing programs. His policy and professional experience would be an exceptional asset to BHA during this time of transition.

APPOINTMENT OF DARRYL MOORE TO THE BERKELEY HOUSING AUTHORITY
BOARD OF COMMISSIONERS

WHEREAS, the Council of the City of Berkeley, as the governing body of the City of Berkeley, declared itself to the Commissioners of the Berkeley Housing Authority (BHA) and appointed two tenant Commissioners pursuant to Health and Safety Code Section 34290; and

WHEREAS, on May 22, 2007 the Mayor appointed and the City Council by a majority vote confirmed the appointment of 5 Commissioners and 2 tenant Commissioners to the BHA Board pursuant to Health and Safety Code Section 34270; and

WHEREAS, Valerie Agostino was appointed to the Berkeley Housing Authority (BHA) Board of Commissioners in 2009 and re-appointed in September 2016; and

WHEREAS, in spring 2018, Ms. Agostino resigned from the BHA Board and there is currently one vacancy on the Board; and

WHEREAS, the Mayor has nominated Darryl Moore, former District 2 City Councilmember, and a Senior Management Analyst with the Oakland Housing Authority, to serve on the BHA Board; and

WHEREAS, during his service on the Berkeley City Council, Mr. Moore oversaw the transition of BHA from the city to an independent agency. He served as a member of the 3x3 Committee of BHA and the City Council throughout his service on the Council and advised BHA during its transition out of troubled status and the disposition of 75 units of public housing; and

WHEREAS, professionally, through his work at the Oakland Housing Authority, Mr. Moore is knowledgeable about HUD regulations and the administration of public housing programs;

WHEREAS, Mr. Moore's policy and professional experience would be an exceptional asset to BHA during this time of transition; and

WHEREAS, the Mayor of the City of Berkeley is an office filled by election of the people of Berkeley.

NOW THEREFORE, BE IT RESOLVED by the Mayor of the City of Berkeley that Darryl Moore is appointed to serve as a Commissioner of the Berkeley Housing Authority Board; and

BE IT FURTHER RESOLVED by the Council of the City of Berkeley that it supports the

Mayor's determination regarding the qualifications of Darryl Moore and hereby confirms the Mayor's appointment; and

BE IT FURTHER AND FINALLY RESOLVED by the Mayor of the City of Berkeley that, pursuant to Health and Safety Code Section 34272(a), Darryl Moore is appointed to serve a four-year term.
