The Berkeley Planning Commission will hold a public hearing on the above matter, pursuant to Section 21.16.044 of the BERKELEY SUBDIVISION ORDINANCE (5793-N.S.), on: **Wednesday, May 24, 2006, at the North Berkeley Senior Center, 1901 Hearst Ave. (at Martin Luther King), Berkeley.** The meeting begins at 7 p.m.

**PROPOSED PROJECT INFORMATION:** The applicant proposes to create an seven (7) unit condominium project at 1414 Harmon Street, Berkeley. The units are proposed to be created in one existing building and three units not yet constructed.

**ENVIRONMENTAL REVIEW STATUS:** Categorically exempt under Section 15315 of the California Environmental Quality Act Guidelines, minor land division.

The public is advised that the Commission may limit the number of speakers and the length of time allowed to each speaker. **LEGAL LIMITATIONS:** If you object to a project or to any City action or procedure relating to the project application, any lawsuit which you may later file may be limited to those issues raised by you or someone else in the public hearing on the project, or in written communication delivered at or prior to the public hearing. The time limit within which to commence any lawsuit or legal challenge related to these applications is governed by Section 66499.37 of the Government Code, unless a shorter limitations period is specified by any other provision. Under Section 66499.37, any lawsuit or legal challenge to any quasi-adjudicative decision made by the City must be filed no later than the 90th day following the date on which such decision becomes final. Any lawsuit or legal challenge, which is not filed within that 90-day period, will be barred.
