We are a B-general contractor. I could not find the license specifically on the documents Q1: and wanted to double check if we are eligible to apply. A1: An A or B license is required. License will be verified on the CSLB web site. Should we consider any night shift work? Q2: A2: Night shift work beyond the operating hours of the central library will not be generally expected or allowed, with the exception of particular predetermined instances based on specific needs. **** Q3: Do you have any budget or estimation of the job? A3: The budget estimate for the job is \$200,000. Q4: Is there an engineer's estimate? A4: See Q3/A3. **** Q5: I was wondering if there is an interested/potential proposer list for the 'Central Children's Storytime Room Remodel' RFP No. 24-11369-C and if so, may I please view it? A5: There is no interested/potential proposer list that can be viewed at this time.
