

## Annual General Adjustments (AGA) Approved by the Berkeley Rent Stabilization Board

1981	5% OR 6.2% if owner paid for space heating
1982	9% plus, if owner paid for gas and electricity, including space heating, the following additional increases: \$4 for studio; \$7 for 1-bedroom; \$9 for 2-bedroom; \$10 for 3-bedroom; \$12 for 4-
	bedroom; \$16 for house with 3+ bedrooms. Owners who deferred this increase could bank a bonus of additional 1% for each year of deferral.

New tenancies started in the immediately preceding calendar year are not eligible for all of the following AGAs (For example, if a new tenancy began in 1998, it is not eligible for the 1999 AGA. It would be eligible for the 2000 and subsequent AGAs.)

Rounding to the nearest dollar amount was allowed for 1981 - 1987, and for 1989 and 1990. Rounding was required for 1988. Beginning with the 1991 AGA, rounding has not been allowed. The yearly increases must be taken sequentially. For example, the 1988 increase may not be taken before the 1987 increase.
