Appendix 1 - Responses to open-ended questions

1. Overview

The City of Berkeley hosted the second in a series of community workshops for the Berkely Marina Area Specific Plan (BMASP) process on March 16, 2022. The project team presented background information on Marina funding and infrastructure needs, ideas for new revenue-generating land uses, and three conceptual land use alternatives. After the presentation, breakout groups formed for participants to discuss and provide feedback on the land use alternatives.

After the workshop, a questionnaire was posted to the <u>project website</u> for the public to provide additional feedback on the land use alternatives presented at the workshop. A total of 820 people responded — 82% from Berkeley, 12% nearby cities, 6% outlying areas. Of a total of 15 questions, eleven focused on revenue-generating land uses and land use alternatives and four asked for the respondent's age, residence, and mode of travel to and specific use of the Marina.

2. Summary of Key Findings (Complete results, page 4.)

A. Revenue-Generating Uses (Questions 3, 5, 7, 9)

Respondents were asked to indicate their support for each of four potential revenue-generating uses as 'Yes', 'No', 'Neutral', or 'Yes with comments.' Results:


B. Land Use Alternates (Questions 4, 6, 8, 10)

Respondents were asked to rate how well each of **three land use alternates** (below) would accommodate each **revenue-generating land use**. The results, in summary:

• **Hotel/retreat**: Alternate 3 modestly stronger support than 1 and 2.

Food/beverage: Alternates 1-3 evenly ranked.
Interpretive facility: Alternates 1-3 evenly ranked.

• Adventure Park II: Alternate 2 modestly stronger support than 1.



C. Complementary Uses

Respondents ranked eight complementary uses in order of preference. Complementary uses are defined as additional appropriate uses at the Marina expressed by the community that could enhance the visitor experience but would not generate any significant new revenue to the Marina. Summary results:

- Highest three preferences: Food trucks; Small boat hourly rentals; Bike Rentals.
- Lowest two selections: Park pavilions; Dog agility course.

D. Park Amenities


Respondents ranked nine park amenities. By a significant margin, the highest ranked amenity was 'Living Shoreline' followed by 'Pathway Improvements', 'Public Restrooms', and 'Tree Plantings'.

E. Events

Respondents were asked to indicate a maximum number of large events/concerts per year they would be in favor of. Results were: Up to 4, 36%; Up to 8, 24%; Up to 12, 20%; and None, 20%.





New Revenue-Generating Land Uses





Are you in support of a new hotel & retreat center at the Berkeley Waterfront?


















Q10: Indicate your support for where an Adventure Park II could be located in the Waterfront. Answered: 497 Skipped: 323




Q11: Events and Regional Gatherings Answered: 677 Skipped: 143 How many total large events and concerts might you support annually?




Q12: Complementary Uses Answered: 664 Skipped: 156 Rank your preference; <u>1 is highest preference</u>.
