You must follow all State, County and City regulations to reduce waste by following the requirements below. Please return the signed form indicating your agreement.

## **Waste Reduction & Disposal Guidelines**

The City of Berkeley requires all event vendors to properly sort all recyclable and compostable materials generated during the event. Well-marked containers must be available to both vendors and attendees. The items listed below will be collected for recycling/composting at the event:

- Recycle bottles, cans, plastic food and beverage containers.
- Compost paper, cardboard, boxes, mixed paper, food waste, food soiled paper and BPI certified compostable foodware

## **1383 Food Donations Requirements**

Vendors with excess food that is still safe for human consumption must donate the excess food to a local food pantry.

## Single Use Foodware and Litter Reduction Ordinance Requirements for Food Vendors BMC 11.64

- All foodware must be reusable or BPI certified compostable.
- All disposable foodware must be recyclable or compostable in the City's Zero Waste program.
- Reusable plates, cups, utensils and other accessory items are preferred

## **Required Plastic Bag Charges BMC 11.63**

- Please avoid providing bags where possible.
- If you must provide bags for food or retail items, the bags must not be plastic, they must be paper or reusable, you may charge ten cents per bag

### **Unacceptable materials**

- o Plastic Bags and Polystyrene foam are banned in Berkeley
- o Electronic Waste must not be disposed in the trash
- o The following items are not recyclable, they must be placed in the trash
  - Milk cartons, juice/soup/broth boxes, plastic wrap, balloons, laminated paper.



Ordinance Requirements for Prepared Food Vendors

# **On-Site Dining Requirements**



- ✓ All foodware utilized for on-premises dining must be reusable.
- ✓ Disposable foodware is prohibited for on-premises dining.
- ✓ Exceptions:
  - ✓ Compostable paper tray liners and wrappers allowed
  - √ Paper napkins & compostable straws allowed upon customer request
  - √ Recyclable aluminum foil allowed for burritos & wraps



## Front-of-House Recycle & Compost Receptacles

- √ Place color-coded recycle and compost receptacles next to trash receptacles available to customers.
- ✓ Post signage above and/or on each receptacle.

# Take-Out Requirements



## BPI-Certified Compostable Foodware

- ✓ Disposable foodware must be BPI-certified compostable.
- ✓ No disposable plastics allowed.
- ✓ Recyclable aluminum foil allowed for burritos & wraps.



### \$0.25 Disposable Cup Charge

- ✓ Charge \$0.25 for every disposable cup provided to customers.
- √ Identify the \$0.25 cup charge separately on menus, menu boards, delivery ordering platforms, and receipts.



## Accessory Items Upon Request

✓ Provide disposable accessory foodware items (e.g. straws, utensils, cup lids, sleeves, stirrers, napkins, etc.) only upon customer request or at self-service stations.

Limited waivers are available for businesses unable to comply with certain requirements.
