CLOSING BUSINESS DECLARATION

Section 1 – Business Information

Complete all requested information that is applicable.

Check the appropriate box indicating how the income taxes for this business is filed and enter the Federal Employer Identification Number (FEIN) or Social Security Number (SSN) that corresponds with the tax filing.

Section 2 - Closing Date

Enter the date the business closed or the date the property sold.

Section 3 – Calculate the Closing Tax Due

- A. Gross Receipts: Enter the business' total gross receipts from January 1 to the end of operation in the same calendar year. For tax codes A and S (Auto Vehicles and Solicitor, respectively), which have flat rates or fees, skip to line E. For tax code Q (Administration Headquarters), enter the business' gross payroll.
- B. Enter allowable deductions for tax codes C, M, and P.
 - Tax codes C and P: amounts paid to subcontractors to perform a job within the City, such as a dentist's payment to a lab to create a mold. To claim a deduction, you MUST attach a letter that lists subcontractor(s)' business name, their address, contractor number (if applicable), and the amount paid to them.

Tax code M: value of raw materials (including cost of energy), or the value of the partially completed product at the time it enters the manufacturing process within the City.

- C. Taxable Gross Receipts: Subtract line B from line A.
- D. Tax: Multiply the amount on line C by the tax rate to determine business license tax amount. Minimum tax rules do not apply.
- E. Additional License Fees: Enter additional fees if your business is located within the Solano or Elmwood Business Improvement District.
- F. Total Amount Due: Add lines D through E.
