3. LAND ACKNOWLEDGEMENT

The City of Berkeley recognizes that the community we live in was built on the territory of Huchiun (*Hooch-yoon*), the ancestral and unceded land of the Chochenyo (*Cho-chen-yo*) speaking Ohlone (*Oh-low-nee*) people, the ancestors and descendants of the sovereign Verona (*Vuh-roh-nuh*) Band of Alameda County. This land was and continues to be of great importance to all of the Ohlone Tribes and descendants of the Verona Band. We acknowledge and honor the original inhabitants of Berkeley, the documented 5,000-year history of a vibrant community at the West Berkeley Shellmound, and the Ohlone people who continue to reside in the East Bay. We recognize that Berkeley residents have and continue to benefit from the use and occupation of this unceded stolen land since the City of Berkeley, it is not only vital that we recognize the history of this land, but also recognize that the Ohlone people are present members of Berkeley and other East Bay communities today. The City

of Berkeley will continue to build relationships with the Lisjan (*Lih-Shawn*) Tribe and create meaningful actions that uphold the intention of this Land Acknowledgement.

PROCESS

The following applicants presented an overview of their practice and proposals in response to the City of Berkeley Informal Proposals for Cube Space Curatorial Services 2024/2025, issued on February 2, 2024.

- Kevin B. Chen
- William Hernandez Luege
- Matthew Villar Miranda

The panelists discussed and evaluated each of the proposals based on the following criteria:

- Ability to successfully research artists that represent all communities; collaborations towards opportunities that build audience and artist experiences.
- Ability to develop concepts into physical space; management of public-facing projects with multiple stakeholders; understanding of project management.
- Ability to communicate curatorial intent and artist talent to the general public; development of new audiences or networks for artists.
- Ability to share comprehension of scope of work and to communicate qualifications.

The panelists then scored the applicants on each criteria using a 1 to 5 point system with the highest total possible score being 80 points. After point tabulation, the panel ranked all scores.

RESULTS

- William Hernandez Luege: 69
- Kevin B. Chen: 61
- Matthew Villar Miranda: 53

PANEL RECOMMENDATIONS

The panel selected William Hernandez Luege as Cube Space Curator for 2024/2025 and recommends this selection to the Civic Arts Commission for approval at their March 27, 2024 meeting.

Festival Title	Start Date	How the festival celebrates Berkeley's cultural richness, historical significance, or community/neighborhood identity
Asian Cultural Festival	4/20/2024	Berkeley and the associated region has a large Asian community, and Martin Luther King Park provides the perfect venue for a street fair celebrating the diversity of Asian culture in the region. The first fair was held on March 12, 2022, with street stalls, food vendors and performance events, and was really well received. Dharma College, has hosted 3 prior events celebrating Asian Buddhist Culture within its own premises in 2019, 2018, and 2017, and enjoys excellent relations with all of the Asian communities living in Berkley, whatever their religious affiliation. The second festival will take place on April 23rd.
<u>Bay Area Book Festival</u>	5/4/2024	The Bay Area Book Festival is a large, unique celebration of Berkeley's literary life and the city's identity as a place of intellectual and creative power. We present hundreds of notable authors – from Berkeley, the broader Bay Area, the nation, and the world – at our large weekend Festival in Downtown Berkeley, where authors engage in thoughtful discussions of interest to residents. The Festival also fosters a love of reading among young people through a large children's area. All programs are curated with an emphasis on our city's values of social justice and equity.
<u>Voice of Roma's Herdeljezi Festival</u>	5/4/2024	The city of Berkeley is home to a small but active group of the Bay Area's few authentic Romani culture-bearers. One of the most supportive communities for Romani rights, music, and dance in the USA, can also be found in Berkeley. For this reason, after a 5-year pandemic-related programming hiatus, Voice of Roma plans to revive its popular annual Herderljezi Festival a celebration of Romani music, dance, foodways, and other forms of cultural expression and a platform for educating the general public about the plight of Roma worldwide in Berkeley in the spring of 2024.
<u>Annual Contemporary Performance</u> <u>Diasporas Festival</u>	5/18/2024	This year we will celebrate our 10th Annual Contemporary Diasporas Festival of Berkeley in the historical landmark Sawtooth Building, a hub for artisans, craftspeople, theaters and schools of the west Berkeley neighborhood. With the Festival we celebrate, foster and share with our community the best practices of equity in an inclusive environment that encourages art forms that celebrate our diversity. The festival covers many contemporary issues such as gender, race, sex, religion and the environment, giving a unique perspective and character to all of our different events, while stringing together Berkeley's different cultural roots.

Festival Title	Start Date	How the festival celebrates Berkeley's cultural richness, historical significance, or community/neighborhood identity
<u>Berkeley Poetry Festival #21</u>	5/22/2024	Berkeley Poetry Festival celebrates Berkeley's legacy of poetry and social activism that makes our literary community vibrant. The festival showcases local poets dedicated to bringing positive change through civic work, political action, teaching, and other work that strengthens the community and promotes literature. Events include local emerging poets performing alongside celebrated poets. The festival culminates in bestowing a lifetime achievement award in partnership with the City of Berkley, which recognizes the work of a local poet who's dedicated their life to community service. The list of past awardees reflects the diverse and historical backbone of poetry in Berkeley.
<u>Ashkenaz Open House</u>	6/2/2024	Ashkenaz Music & Dance Community Center has had a profound impact on Berkeley over the past 50 years, promoting cultural diversity, community building, and social justice activism through music and dance. An Open House event will celebrate cultural richness and community identity by highlighting diverse traditions and bringing people from different backgrounds and neighborhoods together. The event serves as a platform for underrepresented voices, challenging dominant narratives and promoting greater understanding and respect for diverse perspectives and experiences. Ashkenaz has played a vital role in shaping the character of Berkeley and inspiring generations of artists, activists, and community leaders.
<u>5th Annual California Native Ways - A</u> <u>California Indian Arts & Culture</u> <u>Festival</u>	6/8/2024	This festival hosts 50 California Indian artists from across the state in Ohlone Park and offers Berkeley residents a rare opportunity to experience the artistry of diverse California Indian tribes in person with the artists themselves. This festival is strongly supported by the local indigenous community as well as the neighborhood organization Friends of Ohlone Park (FOOP) who provide significant volunteer assistance. The annual festival which began in June 2019 has become a part of the Ohlone Park neighborhood identity. It is the only major annual cultural event in Berkeley exclusively featuring California Indian artisans thus enriching Berkeley's cultural diversity.

Festival Title	Start Date	How the festival celebrates Berkeley's cultural richness, historical significance, or community/neighborhood identity
Berkeley Festival & Exhibition	6/9/2024	Since the mid-1970s, Berkeley has been a North American center for historically informed performance of early music, or music written before 1800. One major reason for the city's continued international prominence in the field is the biennial Berkeley Festival & Exhibition (BFX), founded in 1990 and now in its 18th incarnation. Every other year, the Festival attracts audiences near and far to celebrate Berkeley's vibrant and unique community of early music performers, scholars, amateur musicians, and instrument makers.
<u>Frameline48: The SF Bay Area's</u> International LGBTQ+ Film Festival	6/12/2024	As the world's first, largest, and most widely recognized LGBTQ+ film festival, Frameline is excited to proceed with plans for a City of Berkeley activation during our Frameline48 International LGBTQ+ Film Festival to take place in the San Francisco Bay Area, June 12-22, 2024. Our existing Festival footprint includes Oakland and San Francisco, and we seek to expand into Berkeley to engage filmgoers to attend our local film screening(s) and discussion(s). We plan this as an effective means of acknowledging Berkeley's cultural richness while uplifting the identities of Berkeley residents as supportive patrons of LGBTQ+ groundbreaking media arts.
<u>BERKELEY CA JUNETEENTH FESTIVAL</u>	6/16/2024	Juneteenth-in-Berkeley was started to promote community pride, and bring together South Berkeley businesses and residents in the celebration of a major African American cultural event, culminating in the first annual Festival in 1987. Berkeley Juneteenth is committed to educating future generations about the history and accomplishments of African Americans, by creating programming which highlights African American art, music and culture.
<u>La Peña Culture Festival</u>	6/29/2024	The La Peña Cultural Festival is a celebration of diverse cultural performing arts traditions from Latin America & the Caribbean. The outdoor block party aims to showcase and provide opportunities for 60 BIPOC cultural bearers, artists, artisans, performers, and musicians to sell their work, which is often underfunded and underrepresented. Established in 1975, La Peña was inspired by Chilean "peñas," which are community gatherings centered around music, food, and drink. The festival continues La Peña's commitment to creating community space, and offers visibility to cultural traditions that call Berkeley home.
