NEW REQUESTS

- A proposal for "Hero Pay" has been submitted by SEIU-MCU.
- Requested as an expression of acknowledgment and gratitude to M&C employees who worked on-site and in-person, without the option of telecommuting, from the onset of the pandemic until the City's return-to-work directive in 2021.
- It is recommended by the City Manager that this acknowledgement be expanded across all the City's labor units for employees that meet this criteria for the specified time period (pro-rated for part-time employees).
- Additionally, it is recommended that employees who were deployed as
 disaster service workers during the aforementioned time period and
 performed work in the field that was directly related to pandemic response,
 such as COVID testing be included as well.

NEW REQUESTS

- Many cities and counties have granted such pay, typically in the form of a one-time payment to employees.
- The intent is typically to recognize the risk and exposure such employees, and often their families, experienced during COVID, while many others were able to work more safely, in remote environments.
- Recommendation: Utilize \$2M from Excess Equity/Unassigned Remaining Fund Balance for this purpose to be implemented in the first quarter.


