Subject: Complaint alleging violation of BERA by Elgstrand for Rent Board 2022

On October 26, 2022, Commission staff received the attached complaint alleging that the campaign committee Stefan Elgstrand for Rent Board 2022 (“Committee”) failed to include the required disclaimer information identifying the Committee’s major funding source(s) in a number of campaign communications including a mailer, flyers and website. The complaint also alleges that one or more of these campaign communications contains inaccurate information about endorsements received by two of the candidate’s opponents.

Section 2.12.335 of the Berkeley Election Reform Act (“BERA”) (BMC Chapter 2.12) provides that campaign communications supporting a candidate must include the name of the committee and the phrase “Major Funding Provided By” followed by the name of the contributor, the city of domicile, and the total cumulative sum of contributions by each of the top four contributors over \$250 to the committee within six months of the expenditure. “Contributor” for this purpose includes lenders. (BMC § 2.12.335.A.)

BERA requires the “Major Funding Provided By” disclaimer for the following types of communications:

1. Mailer, flyers and pamphlets of one thousand or more
2. Newspaper, magazine and Internet advertisements
3. E-mails and telephone calls of one thousand or more

(BMC § 2.12.335.B.)

FCPC Regulation R2.12.335, which interprets the above provision of BERA, provides, in relevant part:

The provisions of BMC section 2.12.335 apply to all campaign committees, including candidate committees that have received contributions or loans over \$250 from the candidate.

According to the complaint, the candidate loaned his Committee \$7,500. This amount is reflected in the Committee’s campaign filings. The complaint asserts that, as a result, the

candidate should have been listed on these campaign communications using a “Major Funding Provided By” disclaimer.

Staff will need to investigate further to determine whether the committee was required to include a “Major funding provided by Stefan Elgstrand” disclaimer on any of its communications. Staff will need to perform a thorough review of the committee’s financial disclosures and review the committee’s campaign communications.

Regarding the allegation that one or more of the committee’s campaign communications contains inaccurate information about endorsements received by two of the candidate’s opponents, that issue is not covered by BERA and therefore does not fall under the FCPC’s purview. Staff recommends the FCPC dismiss that portion of the complaint at this time.

Under the Commission’s Procedures, at this stage, the Commission may (1) direct the Secretary to investigate the complaint, to the extent the Secretary has not already done so; (2) dismiss the complaint; or (c) find probable cause to believe BERA has been violated. (FCPC Procedures Section V.B.2.)

Staff recommends the Commission direct the Secretary to investigate the complaint further regarding the alleged failure to provide the proper disclaimer on one or more campaign communications and return at a future meeting with a subsequent report. Staff believes, based upon initial review, that the evidence provided in the complaint is sufficient such that the complaint should not be dismissed with regards to the disclaimers, but is insufficient to support a finding of probable cause of a violation at this stage.

On October 11th, Berkeley Rent Board candidate Stefan Elgstrand filed papers with the City reporting that he had loaned his own campaign \$7,500 (see attached document). This massive cash infusion has allowed him to blanket the city with expensive campaign literature that, in addition to misleading voters about its funding source, contains blatantly and factually inaccurate information about endorsements received by two of Elgstrand's opponents for Rent Stabilization Board.

Legally, major donors to a campaign must be disclosed on all of the campaign's materials and advertisements, including the dollar amount of their contribution. However, Elgstrand omits “Committee Major Funding from Stefan Elgstrand” from all of his campaign literature (see attached document). This fundamentally misleads voters, who will not be aware that Elgstrand's campaign is primarily bankrolled by his own personal funds rather than grassroots support. As of October 25th, Elgstrand’s campaign website also does not list himself as a major funder, even though he reports to have made the \$7,500 loan on October 11th, two weeks prior (see attached document). Nor do flyers for his candidacy dropped at voters' doors over the weekend of October 22nd. Moreover, records show his campaign mailed an advertisement on October 13th, after his \$7,500 loan (see attached document). In fact, his earlier contribution of \$344.31 would have already necessitated such a disclosure.

The mailer and flyers also claim that Elgstrand is the “ONLY candidate endorsed by a majority of the Berkeley City Council.” However, candidate Soli Alpert is endorsed by Mayor Jesse Arreguín, Vice Mayor Kate Harrison, and Councilmembers Sophie Hahn, Rigel Robinson, and Ben Bartlett, five of nine Councilmembers. Candidate Nathan Mizell is endorsed by Mayor Jesse Arreguín, Vice Mayor Kate Harrison, and Councilmembers Sophie Hahn, Rigel Robinson, Terry Taplin, and Ben Bartlett, six of nine. As of October 25th, Elgstrand’s website also makes this false claim.

On behalf of the Berkeleyans for Better Planning Committee (No on Measure L), I am making a formal complaint with the Berkeley Fair Campaign Practices Commission. The Committee for an Affordable and Resilient Berkeley (Yes on Measure L) received a \$25,000 donation on October 15, 2022 from the San Francisco Foundation. The Yes on Measure L contribution report (California Form 497) reported this contribution on October 16, 2022. The form is attached to this letter. Our committee would like the Berkeley Fair Campaign Practices Commission to investigate this donation as we feel this is a failure to report the true source of the contribution and that the San Francisco Foundation is likely acting as a pass through for an individual donor that is not being disclosed by the Yes on Measure L committee.

Subject: Staff enforcement referral regarding failure to file copy of mass mailings by Berkeleyans for Better Planning No on Measure L

On November 8, 2022, staff became aware of one or more potential mass mailings circulated by Berkeleyans for Better Planning No on Measure L (the “Committee”) which may have failed to comply with the requirements for filing mass mailings with the City under the Berkeley Election Reform Act (“BERA”). (See Mailing Images, Attachment 1.)

BERA provides that “a copy of every mass mailing in support of or in opposition to a candidate or measure shall be sent to the commission.” (BMC § 2.12.325.) BERA defines a “mass mailing” as “two hundred or more identical or nearly identical pieces of mail.” (BMC § 2.12.150.)

The Commission’s Regulations require that a committee that has sent a mass mailing must file three copies of the mailing with the City Clerk within one day of the mailing. (FCPC Regs. R2.12.325.2.) Each mailing filed with the City Clerk must be accompanied by a certification, which must include identifying information for the committee, the date of the mailing, and be signed by a committee officer. (FCPC Regs. R.12.325.2; see Mass Mailing Certification Form, Attachment 2.) The City Clerk maintains an index of all mass mailings received from campaign committees. (Mass Mailing Index, Nov. 4, 2022, Attachment 3.)

The City Clerk referred this item to the Commission after determining that the Committee has not filed any mass mailings with the City.

At this point, staff have not confirmed that the Committee failed to meet any obligations under BERA. Staff will need to review the possible mass mailings and then determine what, if any, filing obligations were triggered by the mailings.

Staff recommends the Commission direct the Secretary to investigate this matter and return at a future meeting with a subsequent report.

MASS MAILINGS - FCPC REGULATIONS AND CERTIFICATION

R2.12.325.1 Mass Mailings; Filing

- (a) A mass mailing means two hundred or more identical or nearly identical pieces of mail, but does not include a form letter or other mail which is sent in response to a request, letter or other inquiry as defined in BMC Section 2.12.150 that has been sent within a calendar month.
- (b) Any committee, candidate, officeholder, individual or organization who
 - (1) Has local filing requirements pursuant to the BERA, as it may be amended from time to time, and
 - (2) Makes expenditures supporting or opposing one or more candidates or ballot measures,
 shall file three copies of each mass mailing paid for by expenditures reported therein.

R2.12.325.2 Filing of Mass Mailings - Method of Filing

Three copies of all mailings as defined in BMC Section 2.12.150 shall be filed with the City Clerk’s Office no later than one day of the date the mass mailing was first placed in the U.S. mail. Filing shall be made by hand-delivery to the City Clerk’s Office no later than one day after the mailing or by depositing three originals addressed to the City Clerk’s Office in the U.S. mail on the same day as the first pieces are deposited in the U.S. mail.

If neither of the above conditions can be met, the three copies of the mass mailing and the certification must be sent by guaranteed overnight delivery to comply with the requirement that they be filed with the City Clerk’s Office no later than one day after the date the mass mailing was first placed in the U.S. mail.

Mass mailings may be filed with the City Clerk prior to the date of the actual mailing. Each mass mailing required to be filed with the City Clerk pursuant to BMC § 2.12.325 shall be accompanied by a certification of the date the mass mailing was (or will be) deposited in the U.S. mail. The certification shall include the following information:

- (a) The name of the candidate, committee, officeholder, individual or organization with local filing requirements under the BERA responsible for the mass mailing.
- (b) The campaign filing identification number, if any.
- (c) The date that the mass mailing was (or will be) deposited in the U.S. mail.
- (d) The signature of the candidate, committee, officeholder, individual or organization with local filing requirements under the BERA responsible for the mass mailing. Where a committee or organization is responsible for the filing, the certification shall be signed by the committee or organization treasurer.

The certification may be hand-or type-written by the responsible candidate, committee, officeholder, individual or organization with local filing obligations under the BERA either directly on the mass mailing filed with the City Clerk’s Office, or on a separate piece of paper if the piece of paper is attached to the mass mailing by staple. The certification shall be in a form substantially similar to the following:

Subject: Complaint and request for action regarding posting of minutes by City commissions and use of Live Transcription for public meetings

On October 21, 2022, the Commission Secretary received the attached complaint. (Attachment 1, Email from Kelly Hammargren, received October 21, 2022.) The complaint requests action by the Commission on the following two items:

1. City Commission Minutes

The complaint asserts that City commissions are not complying with City policy requiring that commission meeting minutes be posted online within 14 days of the meeting. (See Attachment 2, Complainant's list of overdue minutes.) The City has adopted a policy that City boards and commissions post their minutes online within two weeks of each meeting. (See Berkeley Commissioners' Manual, p. 43, "It is the secretary's responsibility to . . . post draft minutes within two weeks after the commission meets.")

2. Live Transcription

The complaint requests that Live Transcription technology be used and required for all City meetings as an "open government" standard in order to improve accessibility.

COMMISSION AUTHORITY

The Commission has the authority to receive complaints under the Open Government Ordinance ("OGO"), BMC Section 2.06.190.A.1, which provides in relevant part:

The Open Government Commission shall:

- a) hear complaints by any person concerning alleged non-compliance with this Ordinance, the Brown Act, the Public Records Act, or the Lobbyist Registration

November 10, 2022

Page 2 Re: Hammargren Complaint

Act, by the City or any of its legislative bodies, elected or appointed officials, officers or employees;

b) consider ways to informally resolve those complaints and make recommendations to the Council regarding such complaints;

c) seek advice from the City Attorney concerning those complaints;

d) advise the City Council of its opinion, conclusion or recommendation as to any complaint . . .

Additionally, the OGO provides that the Commission may

propose additional legislation or procedures that it deems advisable to ensure the City's compliance with this Ordinance, the Brown Act, the Public Records Act, and the Lobbyist Registration Act, and advise the City Council as to any other action or policy that it deems advisable to enhance open and effective government in Berkeley. (BMC § 2.06.190.A.2.)

RECOMMENDATION

Neither of the topics in this complaint appear to constitute violations of the OGO, the Brown Act, the Public Records Act, or the Lobbyist Registration Act. However, both topics clearly fall under the Commission's authority under section 2.06.190.A.2 to "advise the City Council as to any other action or policy that it deems advisable to enhance open and effective government in Berkeley."

Staff recommends that the Commission review the complaint and consider whether any advisory opinions or communications to Council are warranted on these topics.

There is no longer a form for making an open government complaint that I could find in the new city website that is not an election (BERA) related complaint.

This complaint is from Kelly Hammargren and I may be contacted by the commission when my complaint is scheduled for review through this same email kellyhammargren@gmail.com.

First note that the Open Government Commission recommended and Council accepted and approved that commission minutes must be posted within 14 calendar days from the meeting. This is not happening. Commissions in increasing numbers are delaying posting minutes until the next meeting. Please take appropriate action/notification to City administration to enforce compliance.

Second we have been attending meetings by zoom since the pandemic emergency began March 16, 2020. Recently a few of the commissions have been activating the "Live Transcription" "Closed Captioning" option. The Live Transcription is an incredible option. It is not 100% accurate depending on the clarity of the diction of the speaker, but it is very close and close enough and accurate enough to follow the meeting discussions and actions.

The option of turning on Live Transcription is huge for persons with disabilities impacting hearing or disabilities in auditory processing. You may have heard the hoopla surrounding John Fetterman candidate for U.S. Senate who post stroke has an auditory processing disorder, but can fully process written word, live transcription, closed captioning.

We now have this incredible service at our fingertips. My request is that the live transcription option be utilized and required for all city meetings as an "open government" standard. As right now persons with disabilities are shut out of meetings that do not utilize this option. And, if all meetings are required to be in-person that does not solve the problem for persons with auditory disabilities.

This request to treat persons with disabilities as deserving of equitable treatment does not end with taking action for Berkeley Boards, Commissions and Committees, accompanying this action please add a letter to Governor Newsom, Assembly Representative Wicks and State Senator Nancy Skinner.

This complaint and call for action is cc'd to the Commission on Disability, the Commission on Aging, the Human Welfare and Community Action Commission, the Community Health Commission, the City Council and the City Manager

Berkeley's voter-approved Public Financing Program allows certified candidates for Mayor, City Council, School Board, Rent Stabilization Board, and City Auditor seats to receive a 6-to-1 match on qualifying contributions of up to \$60 from Berkeley residents (e.g. for a \$50 qualifying contribution, a participating candidate receives \$300 in public matching funds), to a maximum of \$47,000 for City Council candidates \$140,000 for mayoral candidates, \$8,000 for Rent Stabilization Board candidates, and \$20,000 for School Board and City Auditor candidates

INTRODUCTION

Under the Berkeley Election Reform Act, all candidates running for local office, ballot measure committees, certain general purpose committees, and primarily formed committees supporting or opposing candidates and/or measures in the November 8, 2022 Election are required to disclose information regarding individual contributors who give \$50 or more. The Berkeley Election Reform Act requires that the City publish a list of all persons contributing \$50 or more to any candidate or committee in that election and the amounts of the contributions reported through the October 22, 2022.

The list includes contributions from the beginning of the 2022 election cycle through October 22, 2022, which were disclosed on campaign statements received by the City Clerk Department. Copies of the campaign statements including contributions and expenditures are posted on the City of Berkeley's website at the Public Access Portal (<https://www.netfile.com/agency/brk/>) and may be viewed at the City Clerk Department, 2180 Milvia Street, Berkeley.

In 2016, Berkeley voters adopted the Berkeley Fair Elections Act of 2016. This ballot measure created a voluntary program providing public matching funds for candidates running for the office of Mayor, City Council, Rent Stabilization Board, School Board Director, and Auditor. Participating candidates are eligible to receive a 6-to-1 match on qualifying contributions of up to \$60 (e.g., for a \$60 qualifying contribution, a participating candidate receives \$360 in public matching funds). Candidates participating in the Public Finance program are identified by "PF" next to the committee name. Not all contributions are eligible for matching funds.
