#### SUBJECT: Amendments to BERA sections 2.12.415 and 2.12.545 to clarify method for cost of living adjustments for campaign contribution and public financing dollar amounts and to better coordinate adjustment with timing of relevant data availability

Under the Berkeley Election Reform Act (BMC Ch. 2.12.) ("BERA"), the Commission is required to adjust various dollar amounts in accordance with changes in cost of living every odd-numbered year.

These dollar amounts include the following amounts under the City's Fair Elections (public financing) program:

- 1. Qualified contributions (BMC § 2.12.167)
- Minimum qualified contributions required for public financing qualification (BMC § 2.12.500.A.3)
- 3. Aggregate per-candidate matching funds payments (BMC § 2.12.505.B.)
- 4. Maximum value of capital assets purchased with public financing funds (2.12.530.B.3.b.)

In 2021, the Commission and City Council approved an amendment to BERA which provides that the \$250 contribution limit for candidates not participating in public financing shall be adjusted for cost of living in every odd-numbered year. (BMC § 2.12.415.)

This proposed amendment would make the following changes:

#### 1. Clarify that the \$250 contribution limit shall be adjusted in \$10 increments

Pursuant to section 2.12.545, the above adjustments for the public financing program are to be rounded to the nearest \$10 (or \$1,000 for aggregate candidate payments

under 2.12.505.B). This ensures that dollar amounts are adjusted to simple numbers that do not include fractions of a dollar. It also ensures that amounts will not be changed if the cost of living results in an adjustment of less than \$5.

During the FCPC's 2021 discussion of adjusting the \$250 contribution limit it was understood that the same \$10 adjustment threshold would apply. However, this change was not enshrined in the resulting amendment. As a result, the required adjustment to \$250 could result in an adjustment of only a few dollars, including fractions of a dollar. The proposed amendment would clarify that the \$10 rounding applied to other adjustment amounts will also apply to the \$250 limit

### 2. Adjust timing of adjustment to coincide with availability of data

The City Clerk Department prepares the proposed adjustments based on data made available by the Bureau of Labor Statistics ("BLS"). BLS has informed City staff that the adjustment data will likely not be available until the end of January 2023. This was also the case during the last round of adjustments in 2021. The proposed amendment would adjust the timing of the adjustment from January to March in order to allow sufficient time for City staff to acquire the needed data, calculate the necessary adjustments, and prepare a proposal for the FCPC.

The above changes may be accomplished by amending BERA sections 2.12.415 and 2.12.545. A proposed amendment is included as Attachment 1. Pursuant to Berkeley Municipal Code Section 2.12.051, BERA may be amended by the "double green light" process. This process requires that the FCPC adopt the amendment by a two-thirds vote, and that the City Council then hold a public hearing and adopt the amendments by a two-thirds vote.

### ORDINANCE NO.

### AMENDING BERKELEY MUNICIPAL CODE CHAPTER 2.12

BE IT ORDAINED by the Council of the City of Berkeley as follows:

<u>Section 1.</u> That Berkeley Municipal Code Section 2.12.415 is amended to read as follows:

### 2.12.415 Persons other than candidate – Maximum permitted amount.

No person other than a candidate shall make and no campaign treasurer shall solicit or accept any contribution which will cause the total amount contributed by such person with respect to a single election in support of or in opposition to such candidate to exceed two hundred fifty dollars (\$250). The Commission shall adjust the dollar amount in this Section for cost of living changes pursuant to 2.12.075 in JanuaryMarch of every odd-numbered year, or as soon thereafter as practicable. Such adjustments shall be rounded to the nearest ten dollars (\$10). For purposes of this section single election is a primary, general, special, runoff or recall election

<u>Section 2.</u> The Berkeley Municipal Code Section 2.12.545 is amended to read as follows:

### 2.12.545 Cost of living adjustments

The Commission shall adjust the dollar amounts specified in Sections 2.12.167, 2.12.500.A.3, 2.12.505.B and 2.12.530B.3.b for cost of living changes pursuant to Section 2.12.075 in JanuaryMarch of every odd-numbered year, or as soon thereafter as practicable, following Council implementation. Such adjustments shall be rounded to the nearest ten dollars (\$10) with respect to Sections 2.12.167, 2.12.500.A.3 and 2.12.530.B.3.b and one thousand dollars (\$1,000) with respect to Section 2.12.505.B.

#### Subject: Adoption of 2023 FCPC-OGC Joint Concurrent Meeting Schedule

The FCPC and OGC ("Commissions") must set their annual meeting schedule for 2023. Traditionally, the Commissions have met in a concurrent meeting on each third Thursday of the month. Starting last year, the Commissions began meeting at 6 p.m. rather than 7 p.m.

In recent years, the Commissions have not had a regular meeting scheduled in August or December. This practice is continued in the proposed schedule below. The Commissions may need to schedule additional meetings as needed throughout the year.

Throughout the COVID-19 pandemic, City commissions have met via videoconference. Under the Brown Act, City commissions have been able to meet via videoconference while the statewide COVID-19 emergency is in place. It is anticipated that the Governor will end the statewide emergency on February 28, 2023, at which point City commissions will be required to resume in-person meetings. This will mean that the Commissions will resume in-person meetings at their March meeting.

The Commission Secretary has generated the following proposed schedule for the remainder of the year, which the Commissions should feel free to adjust as they see fit:

#### SUBJECT: Election of Commission Officers

City commissions must annually elect a Chair and Vice-Chair. Pursuant to the FCPC's Rules of Procedure, the Chair and Vice-Chair are to be elected at the February regular meeting. The purpose of this agenda item is to allow the Commissions an opportunity to discuss the process prior to the February officer election.

The Chair and Vice-Chair are elected by the majority of the commission for a one-year term and hold office until their successors are elected or until their terms as members of the commission expire. No commissioner shall serve as chair for more than two consecutive years. There is no term limit for vice-chair.

The FCPC's Rules of Procedure outline the following responsibilities for the Chair:

- 1. Preside at all Commission meetings
- 2. Appoint committees and chairpersons of committees
- 3. Approve the agenda prior to distribution
- 4. Sign correspondence on behalf of the Commission
- 5. Administer oaths and affirmations to persons testifying before the Commission
- 6. Provide guidance to the Secretary regarding staff execution of Commission business, including, but not limited to, investigations, reviewing campaign statements and audits of candidates and committees
- 7. Represent the Commission in dealings with the City Manager, the City Attorney, and other City staff
- 8. Represent the Commission before the City Council

  - 9. Exercise the authority of the Commission with regard to administrative matters

The role of the Vice-Chair is to assume the above roles in the absence of the Chair.

Berkeley's voter-approved Public Financing Program allows certified candidates for Mayor, City Council, School Board, Rent Stabilization Board, and City Auditor seats to receive a 6-to-1 match on qualifying contributions of up to \$60 from Berkeley residents (e.g. for a \$50 qualifying contribution, a participating candidate receives \$300 in public matching funds), to a maximum of \$47,000 for City Council candidates \$140,000 for mayoral candidates, \$8,000 for Rent Stabilization Board candidates, and \$20,000 for School Board and City Auditor candidates
