Subject: Mandated Cost of Living Adjustments

Pursuant to newly adopted amendments to the Berkeley Election Reform Act, there are two additional dollar amounts that must be adjusted on a regular cycle, 1) the dollar amount threshold for filing quarterly campaign reports for ballot measure committees; and 2) the dollar amount threshold for listing the "Top Four" contributors on certain campaign communications.

These clean up amendments were adopted to keep these dollar amounts in lock step with the newly adjusted contribution limit. The contribution limit was adjusted upward from \$250 to \$270 in January 2023. This adjustment is an off-cycle adjustment that is needed to keep the amounts tracking at the same dollar amount.

The adjustment for the dollar amounts is based on the Consumer Price Index for the San Francisco Area. The formula the City uses for these adjustments is established by the State Fair Political Practices Commission for adjusting contribution limits for state candidates, and is also used for adjusting the limits for Berkeley's Public Financing Program.

The chart in Attachment 1 shows all of the amounts that are subject to the inflator, the original amount, the new amount (raw and rounded), and the code reference.

Upon approval by the Commission, all manuals and materials related to campaign finance will be updated to reflect the new dollar amounts.

SUBJECT: Election of Commission Officers

City commissions must annually elect a Chair and Vice Chair. Pursuant to the FCPC's Rules of Procedure, the Chair and Vice Chair are to be elected at the February regular meeting. The purpose of this agenda item is to allow the Commissions an opportunity to discuss the process prior to the February officer election.

The Chair and Vice Chair are elected by the majority of the commission for a one-year term and hold office until their successors are elected or until their terms as members of the commission expire. No commissioner shall serve as Chair for more than two consecutive years. There is no term limit for Vice Chair.

The FCPC's Rules of Procedure outline the following responsibilities for the Chair:

- 1. Preside at all Commission meetings
- 2. Appoint committees and chairpersons of committees
- 3. Approve the agenda prior to distribution
- 4. Sign correspondence on behalf of the Commission
- 5. Administer oaths and affirmations to persons testifying before the Commission
- 6. Provide guidance to the Secretary regarding staff execution of Commission business, including, but not limited to, investigations, reviewing campaign statements and audits of candidates and committees
- 7. Represent the Commission in dealings with the City Manager, the City Attorney, and other City staff
- 8. Represent the Commission before the City Council
- 9. Exercise the authority of the Commission with regard to administrative Matters

The role of the Vice-Chair is to assume the above roles in the absence of the Chair.
