

Subject: Semi-Annual Report of Marijuana Enforcement Activity

The table below is a compilation of the marijuana enforcement activity, which occurred in the City of Berkeley, or was engaged in by Berkeley police officers in other cities, during the period of July 1, 2011 through December 31, 2011.

The specific Health and Safety Code sections related to marijuana which were charged are defined in the following table:
