CYRC Meeting of March 25, 2013

Notes on Annual Work Plan discussion:

- **2020 Initiative.** Help other commissions help the 2020 Vision Initiative, e.g., assist the Homeless Commission in how their efforts can affect conditions for youth.
- 2020 Initiative. Our workplan should include seeing through the 2020 Initiative.
- Community Input. We should capture emerging or marginal issues affecting youth.
- Community Input. We should incorporate more voices from the most disadvantaged.
- **Evaluation.** We should focus on assessment and evaluation for linguistic and culturally relevant programs, e.g., indigenous healing practices, culture shift what does it mean to be green?, etc.
- **Evaluation.** We should work on capturing effectiveness of city-supported programs.
- **Funding**. We should clarify transition funding cycles for community agency work.
- Funding. We should finish the community agency funding work, RFP, etc.
- **Funding**. We should focus on funding cycles and youth grants.
- **Indicators**. We should develop indicators for internal programs as well as contractors on how they impact youth, e.g., the Alameda County Childrens' Budget or a "Children in All Policies" book.
- Outreach. We should work on making low-cost recreation more available and visible, e.g. Games of Berkeley events, Poetry Festival, Watershed Festival, etc.
- Outreach. We should work on making Berkeley child, youth, and family-friendly.
- Outreach. We should look at the Alameda County Year of the Child Initiative.
- **Service Infrastructure.** We should encourage other organizations and commissions to help fill in gaps in youth services and programs.
- Service infrastructure. We should focus on gaps in service for ages 0–5 and their families.
- **Service infrastructure.** We should capture a matrix of all programs and services affecting youth in the City in order to look for issues of duplication, gaps, or quality versus auto-pilot problems in youth services and programs.
