Pickleball Court Rules

- 1. Must use “Green Zone” paddles from approved list.**
- 2. Only Onix Pure 2 and NewFit True balls are allowed to be used at these courts.**
3. Players are requested to observe pickleball court courtesies as well as rules of good conduct on and around pickleball courts.
4. Playing on the courts without athletic shoes is forbidden. An athletic shoe is footwear with rubber soles, primarily designed for sports and other forms of physical exercise.
5. No bicycles, skateboards, roller-skates, rollerblades or pets are allowed on the courts. Food and beverages are discouraged.
6. Two or more players are allowed up to fifteen (15) minutes (up to 2 hours for reservations) of court time for rallying or time enough for playing one game. All players must have a partner to use a court.
7. Whenever there are players waiting, all players must vacate courts after playing fifteen (15) minutes (up to 2 hours for reservations) or one game. Winners shall have no prior rights to remain on the courts.
8. Players waiting to use a court must indicate in some clear way to those using the courts that they are waiting to use the court.
9. The City of Berkeley shall have priority use for City or City-sponsored activities.
10. No individual, group, club, or organization shall occupy pickleball courts for tournament play without written permission from the City of Berkeley Recreation Office. Application must be made at least fourteen (14) days in advance of dates set for start of play.
11. Pickleball court reservations shall not be permitted to individuals, groups, associations, clubs, or organizations desiring such use for “private gain”, which term is defined and herein to mean use of the principal purpose of making a profit not pledged to be devoted to public uses.
12. Reservations are not posted by the City. The permittee will be responsible for providing proof of their reservation (in the form of a printed or online receipt) if requested by another player.
13. Reservations are non-transferable.
14. There are no refunds for pickleball court reservations.
