**RE: DEVELOPMENT OF ED ROBERTS CAMPUS, ADELINE STREET**

Thank you for your letter of March 30, 2005. Of particular value was your clear and affirmative statement regarding historic properties with the undertaking's area of potential effects (APE).

The City has now determined that the following properties are eligible for inclusion in the National Register of Historic Places at the local level of significance:

- 1985 Ashby Avenue; criterion C
- 3031-51 Adeline Street; criteria A and C
- 3192 Adeline Street; criteria A and C
- 2022 Emerson Street; criterion C
- 2015 Prince Street; criterion C
- District comprising 16 Colonial Revival residences, 3004 -3106 Martin Luther King, Jr. Way (west side); criterion C
- District comprising commercial buildings at intersection of Ashby Avenue and Adeline Street, including 1979 Ashby Avenue, 1985 Ashby Avenue (Webb Block), 2990 Adeline Street, 2982 Adeline Street, 2970 Adeline Street, 3021 Adeline Street, 3025 Adeline Street, and 3027 Adeline Street; criteria A and C
- District comprising residential and commercial buildings in a streetcar suburb bounded by south side of Ashby Avenue, west side of Shattuck Avenue, north side of Woolsey Street and east side of Adeline Street (excluding the Ed Roberts campus site), criteria A and C


The City has further determined, based on a recommendation from the North Coastal Information Center, that there is a very low possibility of Native American or historical-period archeological deposits in the APE.
