NOTICE OF STUDY SESSION

2211 Harold Way

Use Permit #13-10000010 to construct a mixed-use development, up to 18 stories in height, containing 302 dwelling units, approximately 10,597 square feet of ground-floor commercial space, a ten-theater cinema complex (approximately 21,641 square feet), and 177 underground parking spaces, located in Downtown Berkeley. The project includes removal of the 1926 addition and portions of the 1913 addition to the landmarked Shattuck Hotel.

The Zoning Adjustments Board of the City of Berkeley will hold a study session on the above matter, pursuant to Zoning Ordinance Section 23B.32.020, on **Thursday, September 10, 2015** at the Maudelle Shirek Building, 2134 Martin Luther King, Jr. Way, second floor Council chambers (wheelchair accessible). **This study session will start at 6:00 p.m. and end at 7:00 p.m.** (the regularly scheduled Zoning Adjustments Board meeting will start at 7:00 p.m.).

PERMITS REQUIRED:

- Use Permit to demolish a main building used for non-residential purposes
- Use Permit to construct a Mixed Use Development
- Administrative Use Permit to allow over 2,000 square feet of Full Service Restaurant space
- Use Permit to allow service of distilled spirits incidental to food service
- Administrative Use Permit to allow service of beer and wine incidental to food service
- Administrative Use Permit to allow amplified live entertainment incidental to food service
- Use Permit to construct over 10,000 square feet of new floor area
- Use Permit to allow building height of over 120 feet but not more than 180 feet
- Administrative Use Permit to allow mechanical penthouse to exceed maximum building height
- Use Permit to allow building height over 120 feet more than 120 feet in width
- Design Review and Structural Alteration Permit to allow alteration and construction on a designated landmark site

APPLICANT: Rhoades Planning Group, 505 17th St., 2nd Floor, Oakland CA

ZONING DISTRICT: C-DMU Core, Commercial Downtown Mixed Use; Core Sub-Area

ENVIRONMENTAL REVIEW STATUS: The ZAB certified the Final Environmental Impact Report (EIR) prepared to evaluate the potentially significant environmental impacts of the proposed project, pursuant to the California Environmental Quality Act, at their June 25, 2015 meeting.

Notice Concerning Your Legal Rights

If you object to a decision by the Zoning Adjustments Board regarding a land use permit project, the following requirements and restrictions apply:

1. If you challenge the decision of the City in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the Zoning Adjustments Board at, or prior to, the public hearing.
2. You must appeal to the City Council within fourteen (14) days after the Notice of Decision of the action of the Zoning Adjustments Board is mailed. It is your obligation to notify the Land Use Planning Division in writing of your desire to receive a Notice of Decision when it is completed.
3. Pursuant to Code of Civil Procedure Section 1094.6(b) and Government Code Section 65009(c)(1), no lawsuit challenging a City Council decision, as defined by Code of Civil Procedure Section 1094.6(e), regarding a use permit, variance or other permit may be filed more than ninety (90) days after the date the decision becomes final, as defined in Code of Civil Procedure Section 1094.6(b). Any lawsuit not filed within that ninety (90) day period will be barred.
4. Pursuant to Government Code Section 66020(d)(1), notice is hereby given to the applicant that the 90-day protest period for any fees, dedications, reservations, or other exactions included in any permit approval begins upon final action by the City, and that any challenge must be filed within this 90-day period.
5. If you believe that this decision or any condition attached to it denies you any reasonable economic use of the subject property, was not sufficiently related to a legitimate public purpose, was not sufficiently proportional to any impact of the project, or for any other reason constitutes a "taking" of property for public use without just compensation under the California or United States Constitutions, the following requirements apply:
 - A. That this belief is a basis of your appeal.
 - B. Why you believe that the decision or condition constitutes a "taking" of property as set forth above.
 - C. All evidence and argument in support of your belief that the decision or condition constitutes a "taking" as set forth above.

If you do not do so, you will waive any legal right to claim that your property has been

taken, both before the City Council and in court.
