On the December 8, 2016 ZAB agenda was the review and comment on the 1900 Fourth Street Draft EIR. A presentation was given by staff, some questions by ZAB were posed, public comments were heard, there was some discussion by ZAB and then the item was continued to January 12, 2017.
