## **5. CHAIR'S REPORT**

- Chair Calavita thanked Comms. Perezvelez and Allamby for serving as last year's Chair and Vice-Chair, and Comm. Mizell for serving as Vice-Chair this year.
- The Chair thanked fellow commissioners for electing her, and looks forward to an interesting and challenging year, which may include a Charter amendment on the November ballot to reform the PRC.
- Chair is interested in addressing fair and impartial policing issues. She will bring periodic updates from Mayor's Fair & Impartial Policing Workgroup; she is a member along with Comms. Ramsey (who is chair) and Mizell. She is on a subgroup for community outreach; will also use as outreach for PRC.
- Comm. Ramsey added that the Workgroup's next meeting is Feb. 19. Trying to be done by June. Making good progress.

## **6. PRC OFFICER'S REPORT**

The PRC Officer reported:

- BOI scheduled for last Friday but complainant did not appear, so complaint dismissed. No new complaints filed since last meeting; no active cases currently.
- Surveillance Technology Report was on City Council's Jan. 28 agenda; by consent Council approved Surveillance Use and Acquisition Policies for GPS trackers, and postponed the body-worn camera and automated license plate reader policies to the Feb. 25 meeting.
- Next PRC meeting in 3 weeks, Feb. 26.
- City is observing holidays on Feb. 12 and Feb. 17.

Chief Greenwood reported that his main focus right now is on staffing. Aiming for 181 sworn and currently at 172.
