PRESENTATION: Cost Effective Green Infrastructure -Mukul Malhotra from MIG gave an impressive presentation on Green Infrastructure.

INFORMATION ITEMS:

- 1. Paving Plan & GI Update: Staff reported that the City of Berkeley Department of Finance is planning to request the City Council authorize the issuance of a \$15,000,000 of General Obligation Bonds (the second series) for the Measure M Street and Integrated Watershed Improvements in June 2016. Due to timing of issuance of the second series of Measure M Bonds, funding was not available to pave all the streets included in the 5 year plan for 2016. Paving of several streets were deferred and are planned to be paved in 2017 instead. Similar deferrals are planned for streets originally scheduled to be paved in 2017. Over the next several months staff and the PWC will work together to develop the 2016 Five Year Paving Plan. The following general schedule was presented and accepted as a good working model by the PWC:
 - 6/2/2016 PWC Meeting Staff Present 1st Draft 2016- 5 Year Paving Plan.
 - June/July/August Staff meet with Paving Sub Committee 2 to 3 times to review Paving Plan.
 - 9/1/2016 PWC Meeting Staff Present "Final Draft" 2016 5 Year Paving Plan.
 - 11/1/2016 City Council Adopt 2016 5 Year Paving Plan.

Staff was asked to provide the Commission a list of streets currently scheduled for construction in 2016.

In addition, staff presented information on the Municipal Regional Permit 2.0 Green Infrastructure Planning requirements. During the next 5 years the City is required to develop a Green Infrastructure Plan. Staff will be meeting with the Watershed Subcommittee to discuss the required planning efforts and solicit input.

- 2. **Public comment procedures by PWC:** Staff presented information from several sources on public comment procedures allowed by the Brown Act. The Commission discussed the options available for scheduling public comment but did not take action to change the current procedures in which all public comment is taken at the beginning of the agenda.
