1. Roll call – Chair Selawsky called the meeting to order at 7:03 p.m.

Aimee Mueller called roll.

Commissioners present: Chang, Laverde, Murphy, Poblet, Simon-Weisberg, Townley, Tregub (left at 8:05 p.m. and returned at 8:28 p.m. for Closed Session), Selawsky.

Commissioner absent: Soto-Vigil.

Staff present: Brown, Darrow (Closed Session only), Kelekian, Law (in audience), Mueller,

Siegel (Closed Session only).

2. <u>Approval of Agenda</u> – M/S/C (Tregub/Chang) MOTION TO APPROVE AGENDA WITH THE FOLLOWING CHANGE: MOVE ACTION ITEMS 6.a.(1) AND 6.a.(2) TO CONSENT. Voice vote. Carried: 8-0-0-1. Absent: Soto-Vigil.

3. Public Forum – There were two speakers. Krista Gulbransen announced an event being held by the Accessory Dwelling Unit Task Force on Thursday, January 25 at 6:00 p.m. at Longfellow to educate homeowners and the community about accessory dwelling units, including the benefits, how to add them, and the barriers to adding them. Christine Schwartz thanked the Board for their efforts to support AB 1506 (repeal of Costa-Hawkins), and mentioned that a recording of a recent forum on affordable housing is available on her Facebook page and the website for Berkeley Citizens Action.

Several Commissioners made announcements: Commissioner Poblet announced that Alameda County has partnered with several organizations to form the Alameda County Legal and Educational Partnership to assist those impacted by Immigration and Customs Enforcement (ICE) raids, and has a rapid response hotline that can be reached at 510-241-4011. Commissioner Murphy spoke about services available to veterans and the families of veterans through Swords to Plowshares (which has a location in Oakland at 27th St. and Telegraph Ave.), including help with payment of back rent. Commissioner Tregub announced an event, "Our Beloved Oakland," on February 18th at 7:00 p.m. at the Fox Theater in Oakland.

a. <u>Election of Chairperson:</u> Commissioner Tregub nominated Commissioner Selawsky, and he accepted the nomination. Commissioner Murphy nominated Commissioner Townley, and he declined the nomination.

Chair Selawsky expressed excitement about the coming year and said the Board has a lot of work to do, including ramping up efforts to repeal Costa-Hawkins.

b. <u>Election of Vice Chairperson:</u> Commissioner Simon-Weisberg nominated Commissioner Laverde, and she accepted the nomination.

MOTION TO ELECT COMMISSIONER LAVERDE AS THE BOARD'S VICE CHAIR. Roll call vote. YES: Chang, Laverde, Murphy, Poblet, Simon-Weisberg, Townley, Tregub, Selawsky; NO: None; ABSTAIN: None; ABSENT: Soto-Vigil. Carried: 8-0-0-1.

Vice Chair Laverde expressed excitement over the coming year, and also spoke about the challenge of repealing Costa-Hawkins.

c. Comments from the newly-elected Chair, Vice Chair and Boardmembers
Chair Selawsky and Vice Chair Laverde made comments after their respective elections.
Chair Selawsky mentioned that he hopes to see Commissioner Laverde as Chair next year. Commissioner Simon-Weisberg thanked her fellow Commissioners for their work and expressed excitement about the coming year. She also spoke about interactions with the public who have praised Rent Board staff for their work and accessibility.
Commissioner Townley expressed hope that Commissioner Laverde would assume the position of Chair next year, and expressed his gratitude for the opportunity to serve on

the Board and continue to fight for affordable housing in Berkeley during his final year as a Commissioner.
