BE IT RESOLVED by the Rent Stabilization Board of the City of Berkeley as follows:

WHEREAS, pursuant to Government Code section 54954, the Brown Act, a legislative body shall provide the time and place for holding regular meetings; and

WHEREAS, the schedule for holding regular meetings has changed since the Resolution Number 96-13;

NOW, THEREFORE, BE IT RESOLVED that the Berkeley Rent Stabilization Board establishes its regular meetings are held at 7:00 p.m. in the Council Chambers at 2134 Martin Luther King Jr. Way, on the third Monday of each month, unless the Monday falls on a City of Berkeley holiday, in which case, the regular meeting is held on the next Thursday; and

BE IT FURTHER RESOLVED that the Board may, from time to time, cancel a regular meeting by announcing the cancellation at a regular meeting; and

BE IT FURTHER RESOLVED that that the Board may, with proper notice, call special meetings if the need arises to supplement the regular meeting schedule; and

BE IT FURTHER RESOLVED that the Board Commissioners will reserve the first Monday of each month for potential special meetings, unless the Monday falls on a City of Berkeley holiday, in which case, the Commissioners will reserve the following Thursday.
